have agreed as follows:

PROJECT: 1HARD/3.1/75 "JOINT CROSS-BORDER NETWORKING INFRASTRUCTURE OF TECHNICAL UNIVERSITIES OF IASI AND MOLDOVA"

CONTRACT TITLE: EXECUTION OF THE STRUCTURED CABLING (Budget Line 3.2.1.) within the project 1HARD/3.1/75 "JOINT CROSS-BORDER NETWORKING INFRASTRUCTURE OF TECHNICAL UNIVERSITIES OF IASI AND MOLDOVA"

Identification number: 1HARD/3.1/75

Whereas the contracting authority would like the contractor to carry out the following works:

Construction of EXECUTION OF THE STRUCTURED CABLING and has accepted a tender by the contractor for the execution and completion of such works and the remedying of any defects therein.

It is hereby agreed as follows:

(1) In this contract, words and expressions shall have the meanings assigned to them in the contractual conditions set out below.

- (2) The following documents shall be deemed to form and be read and construed as part of this contract, in the following order of precedence:
 - (a) the contract,
 - (b) the special conditions,
 - (c) the general conditions,
 - (d) the technical and/or performance specifications,
 - (e) the design documentation (drawings),
 - (f) the breakdown of lump-sum price,
 - (g) the tender,
 - (h) any other documents forming part of the contract.

The various documents making up the contract shall be deemed to be mutually explanatory; in cases of ambiguity or divergence, they shall prevail in the order in which they appear above. Addenda shall have the order of precedence of the document they are amending.

- (3) In consideration of the payments to be made by the contracting authority to the contractor as hereinafter mentioned, the contractor undertakes to execute and complete the works and remedy defects therein in full compliance with the provisions of the contract.
- (4) The contracting authority hereby agrees to pay the contractor in consideration of the execution and completion of the works and remedying of defects therein the amount of:
 - Contract price (excluding VAT/other taxes) 4.742.581,49 Lei MD.

(For the present Contract, the VAT constitutes zero Lei MD according to the Government Decision no. 149 of 09.03.2022 point 293³¹⁴ (8721194917017), by which amendments were made to the Government Decision no. 246 of April 8, 2010 on the application of fiscal and customs facilities related to the implementation of ongoing technical and investment assistance projects, which fall under the scope of international treaties to which the Republic of Moldova is a party.)

(5) The parties agree to the set of rights and obligations described in the attached contractual documents, with the following main characteristics, further detailed in the attachments:
