Floor Wooden platform, height 4Cm, 224 m2, island type with 4 open sides. White floor sticker and green carpet (similar to natural grass) with high floor clearance, according to the design in total 224m2. 3. Stand construction NOTE:1 dedicated stands for Wine of Moldova will be built, open in 4 parts (island type) with the provision of 38 stands (exhibitor counters) at the stand. The total area of the stands will be 224 m2. The walls will be made of laminate (wood Sonoma) according to the design, 6 m high with a WoM logo, and shields type winetec for stoking wine bottles 2 side. 4. Activation area - made of wood laminate, according to the design, with incorporate shields for wine bottles, includes the digital print, the walls include the Wine of Moldova logo made of artificial grass. This area will have colored LED lights to create a special atmosphere. 5. Stands for exhibitors - Stands for exhibitors, size 80 cm - made of laminate according to the design, with storage space with drawers with handles and lock, with LED illuminated logo on the front and on the dividers. Element for plants with LED strip. 38 pieces. One high chair for each exhibitor.
