According to **Regulation (EU) 2017/745 (MDR)**, medical devices are defined as "any instrument, apparatus, appliance, software, implant, or similar product intended by the manufacturer for specific medical purposes." None of the products listed in **Annex A** are designed or intended for use in direct human medical treatments or procedures.

As per **Regulation (EU) 2017/746 (IVDR)**, in vitro diagnostic (IVD) devices are defined as "devices intended for the examination of specimens derived from the human body for medical purposes." The products in **Annex A** are not intended to be used in the diagnosis, monitoring, or prevention of medical conditions and are strictly intended for general laboratory applications.
