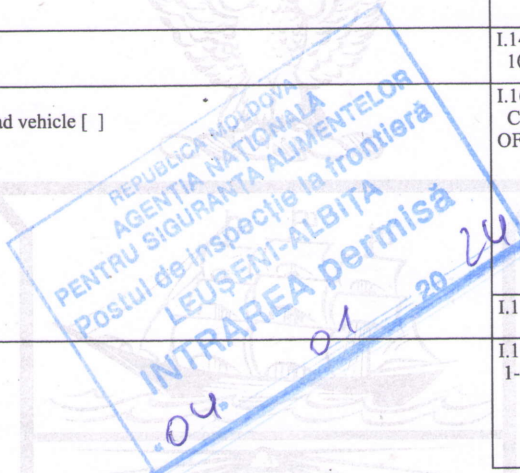

**II.1 Public health attestations**

The official inspector hereby certifies that the fishery products specified above:

4. Were under the supervision and inspection by the competent authority in the origin country and found not to have any pathogenic bacteria or harmful substance, and are fit for human consumption and not intended for any other end users.

**II.2 Animal health attestations**

5. If the animals/products are from aquaculture origin, establishments have not experienced unexplained mortality events at the time of collection/harvest.

The animals/products originate from the United States, where listed notifiable diseases of aquatic animals are reported by the competent authority for aquatic animal health to the World Organization for Animal Health - WOAAH (formerly known as the OIE) in accordance with the WOAAH Aquatic Animal Health Code.
7. The animals/products in the shipment are not under any restriction for disease, and are not intended for destruction for reasons of animal disease.
8. **Molluscs:** Abalone herpesvirus, Bonamia exitiosa, Bonamia ostreae, Marteilia refringens, Perkinsus marinus, Perkinsus olseni, Xenohalotus californiensis
