Test method: The migratory behaviour is examined with reference to Chapter V, Article 18 of Commission Regulation 10/2011/EU and its amendments. Deviating to the regulations the following tests were performed as orientating single tests.

Limit: With reference to Commission Regulation No 10/2011/EU and amendments.

The following food simulants and conditions were applied:
