## DONAU LAB SRL Mühlbauer ID Services GmbH

The Public Services Agency (PSA) notifies about the results of the evaluation of the bids submitted and the award to the successful tenderer within the procedure of request for price quotations no. <u>ocds-b3wdp1-MD-1721052110425</u> of August 12, 2024, for the procurement of the test equipment of machine-readable passports (MRP) and identification cards (ID).

According to the decision of the Working Group for public procurement of the PSA, the economic operators whose bids meet all the requirements set out in the award documentation and the "*lowest price*" award criterion are designated the winners of this public procurement procedure with the awarding of contracts, as follows:

- **DONAU LAB SRL** for the **lot no. 1** (*Equipment for carrying out tests* according to art. 8.5 (art. 10.6) "Impact stress method" from the standard SM ISO/IEC 18745-1:2018 (ISO/IEC 18745-1:2018)),

- Mühlbauer ID Services GmbH (Germany) for the lot no. 2 (Equipment for carrying out tests according to art. 8.11 (art. 10.15) "Abrasion stress method" from the standard SM ISO/IEC 18745-1:2018 (ISO/IEC 18745-1:2018)).

Considering the above mentioned, in accordance with the existig regulatory framework, the public procurement contracts shall be concluded with the economic operators **DONAU LAB SRL** and **Mühlbauer ID Services GmbH (Germany)**.

The winning economic operators are requested to submit:

- The Performance security of the contract (5% of the amount of the contract, including VAT (applicable for DONAU LAB SRL as resident company) and excluding VAT (applicable for Mühlbauer ID Services GmbH (Germany) as non-resident company), according to the provisions of article 68 paragraph (8) of Law no. 131/2015 on public procurement, before the signing of the public procurement

contract, a fact provided for in the tender documentation, as, in case of failure to submit the performance security, or in case of the refusal to sign the contract within the period established in the tender documentation, the PSA has the obligation to retain the Bid security;

- The Declaration on own responsibility confirming the identity of the beneficial owners and their non-compliance in a situation of conviction for participation in the activities of a criminal organization or group, for corruption, fraud and / or money laundering, within 5 days after the date of communication of the results of the public procurement procedure, to the contracting authority and Public Procurement Agency.
