With this document, EAST-TEST SRL, as an authorized entity, proposes the manufacturer's warranty for:

 Vehicle for Extinguishing Forest Fires IVECO EUROCARGO ML150E25WS / WISS SAMOCHODY SPECJALNE SPÓŁKA Z OGRANICZONĄ ODPOWIEDZIALNOŚCIĄ

The warranty period begins on the date of transfer of the equipped Goods to the Purchaser.

- Vehicle warranty period is 5 years (60 months) or 150 000 km (whichever occurs first). The warranty applies to:
 - 1 year all components and labor except those indicated in this document
 - 2 year vehicle's powertrain system
 - 3 year engine, gearbox
 - 4 year engine, gearbox
 - 5 year engine, gearbox

In the event of damage to the goods (including the superstructure) during the warranty period, the customer must contact the seller, **EAST-TEST SRL** for repair works. The company is authorized by the manufacturer **IVECO Spa** and is the official dealer of the IVECO brand in the Republic of Moldova, has an authorized service center approved by **IVECO Spa**.

To maintain the warranty, the costumer is obliged to:

• Follow the periodic maintenance plan and operating instructions (these documents will be given to the buyer together with the vehicle). The seller has the right to suspend the warranty period of the vehicle if the buyer does not follow the periodic maintenance plan and operating instructions of the vehicle and superstructure.

Mandatory:

- M1 30000 km or at the end of the first year of operation
- M2 60 000 km or at the end of the second year of operation
- M1 90 000 km or at the end of the first year of operation
- M2 120 000 km or at the end of the second year of operation
- M1 150 000 km or at the end of the first year of operation

Recommendation:

The first M1 technical intervention will be done at 15 000 km.

Important:

30 000 km is approximately 600 engine hours.

- During the warranty period, any kind of service (including any welding works on the vehicle and superstructure, on the tire valve or its sensor services; on superstructure or it's details services) and spare parts purchase should be implemented only from the supplier, namely EAST-TEST SRL.
- The buyer is obliged not to turn off or change the mileage meter for any reason, as well as to violate the integrity of the seal of the factory-sealed details.

For vehicle Warranty does not apply to:

- For rapid wear parts such as tires, tire valve and pressure sensor, oil, refrigerant and other fluids, belts, filters, shock absorbers, brake pads, ignition / heating plugs, etc. also the non-genuine parts which are not fitted by the manufacturer.
- Damages to structural and other parts caused by the failure of consumable parts (brake disc and pads, brake linings.) not replacement in timely manner;
- On brake discs; On stabilizer rubbers; On the wear of other details containing rubber, raw rubber, plastic.
- Pressure plate, pressure disc and clutch bearing (Clutch system)
- Electric bulbs and fuses;
- Generator and air conditioner belts;
- Wiper Blades;
- Fuel system if after inspection will be found a trace of water, dirt or contamination.
- Rubber or plastic hoses which can be damaged by external factors, such as dust, freeze etc.

The warranty does not apply to the following works:

- Engine adjustment and computer diagnostic;
- Work related to diagnosis and inspection of the brake test, adjustment of the brake system;
- Correction of driveline geometry (wheel alignment)
- Adjustment of doors, hood, trunk roof, hatch roof;
- Adjusting of the headlights lighting;

The warranty does not apply if the damage is caused by mechanical, external factors, rough and careless use of equipment, including:

- Accidents, collisions, fires or explosions; As a result of deep immersion in water;
- By theft, vandalism, etc.
- As a result of natural disaster, such as frost, hail and etc;
- As a result of the use of equipment as a stationary source of electricity;
- Modifications to factory electrical and mechanical components of equipment;
- As a result of using fuel, oils, grease, coolants, brakes, hydraulics and other liquids that do not meet the manufacturer's standards, etc.
- Damage caused by exceeding the maximum load capacity established by the vehicle and equipment manufacturer.
