

 - For Anaesthesia: Breathing systems, carbon dioxide absorbents, catheter mounts, connectors, breathing filters, heat and moisture exchanging filters, masks and attachments, monitoring and pressure lines and filters, reservoir bags, resuscitation systems and masks, tubing and attachments, valves - directional, positive end expiratory pressure, pressure limiting, and exhalation.
 - For Critical Care: breathing filters, breathing systems, catheter mounts, connectors, heat and moisture exchangers, heat and moisture exchanging filters, heated wire breathing systems and attachments, humidification chambers, lung volume recruitment systems, masks and attachments, monitoring and pressure lines and filters, oral care treatment - suction and irrigation toothbrushes and kits, resuscitation systems and masks, suction devices - tubing and wands, tubing and attachments, valves - directional, positive end expiratory pressure, pressure limiting and exhalation, venturi valves for oxygen therapy, electrically powered moisture condenser for breathing systems


