

# ONE YEAR CONSUMER BIN WARRANTY

## 1. Mingou 1 Year Bin Warranty

For all new carts, Zhejiang Mingou Technology Co., Ltd. warrants that they will meet applicable specifications and be free from defects in material and workmanship while in normal use for a period of One (1) year from the initial date of shipment from Zhejiang Mingou Technology Co., Ltd.'s distribution facility.

## 2. Exclusions from Warranty Coverage

2.1 Normal wear and tear for serviceable containers.

2.2 Negligent and Abusive Use: including improper storage, use and handling, vandalism, and damage from wildlife.

2.3 Damage from incompatible, improperly installed, operated, or damaged lifting mechanisms.

2.4 Improper use of container exceeding specifications.

2.5 Unauthorized repair or alteration.

2.6 Damage caused by natural calamities such as fire, storm, or high winds.

2.7 Theft.

The types of damage excluded from this warranty will be determined, each on its own merit, by a representative of Zhejiang Mingou Technology Co., Ltd.

## 3. Warranty Administration

3.1 The consumer shall notify Zhejiang Mingou Technology Co., Ltd. before the end of the warranty period for the allegedly defective container(s).

3.2 The affected container may be taken to an authorized service center designated by Zhejiang Mingou Technology Co., Ltd. for inspection or exchange.

3.3 The consumer agrees to have the container empty and free of refuse.

3.4 The consumer agrees that Zhejiang Mingou Technology Co., Ltd. shall have the right to inspect and test the allegedly defective container(s).

3.5 At the time a claim is filed, the containers become the property of Zhejiang Mingou Technology Co., Ltd. The company reserves the right to collect, reclaim, and recycle the container(s).

## **4. Exclusive Warranty Remedy**

Upon determination of containers/parts as defective by Zhejiang Mingou Technology Co., Ltd., said product shall, at the company's sole option, be repaired, replaced, or credit shall be given for the original purchase price of the affected product. Any repaired or replaced containers/parts will assume the remainder of the One (1) year (or applicable) warranty from the original container's initial shipment date.

This warranty is in lieu of any other remedy or warranty, express or implied, including any implied warranty of merchantability or fitness for a particular purpose. In no event shall Zhejiang Mingou Technology Co., Ltd. be liable for incidental or consequential damages or delay in performance resulting from the defect.
