The invalid or unenforceable provision shall be replaced, to the extent possible, by a valid and enforceable provision covering the economic purpose and intended meaning of the invalid or unenforceable provision the parties have originally meant to determine. To be effective, additional agreements and amendments to this contract are only valid if made in text form. This means that additional agreements and amendments can be made by e-mail. This requirement of text form can only be waived in text form.

# Applicable law and place of jurisdiction

This contract is subject to the laws of the Federal Republic of Germany. For any dispute arising out of or in connection with this contract the place of jurisdiction is Frankfurt am Main, Germany insofar as the applicable statutory provisions do not necessarily provide otherwise.

### **Confirmation of General Terms and Conditions**

By signing this contract, the Contractor confirms to have read and agreed to the General Terms and Conditions which were sent as an appendix to the contract.

# Confirmation of Code of Conduct for Business Partners

### Working hours & Travel

As follows:

- Payment of 100 % of the fee via the project cash desk, following approval of the consultancy deliverable(s) as per ToR by AFC and its Clients.

In case of assignments lasting longer than one month, monthly invoicing and presentation of time sheets is required.

### Documents to be submitted

The Contractor's entitlement to remuneration for a given project activity is substantiated by the following documents:
