## Otto Kuennecke GmbH IAI industrial Systems B.V. Muhlbauer ID Services GmbH

The Public Services Agency (PSA) notifies you about the results of the evaluation of the bids submitted within the open tendering procurement procedure no. ocds-b3wdp1-MD-1701439098721 of 15.02.2024 for the *Procurement of specialized equipment for personalizing polycarbonate cards*.

Pursuant to the decision of the Working Group for Public Procurement, based on the provisions of art. 69 para. (6) letter a) of Law no. 131/2015 on public procurement, the bid submitted by the economic operator **Otto Kuennecke GmbH** is not accepted, because it does not meet the qualification and selection requirements, as the economic operator did not submit the bid according to the requirements set out in the tender documentation. The economic operator did not complete and submit the documents that should be part of the bid (technical proposal, financial proposal, ESPD, bid security), as well as the request for participation and the declaration on bid validity.

Thus, according to the decision of the Working Group for Public Procurement, the contract has been awarded to the winner of this open tendering procurement procedure - the economic operator **IAI industrial Systems B.V.** which submitted the bid that corresponds to all the requirements set out in the tender documentation.

Subsequently, it should be noted that the economic operators **Muhlbauer ID Services GmbH** proposed a bid with a higher price in relation to the accepted and compliant bid of the successful economic operator designated as the winner.

Considering the above mentioned, according to the normative framework in force, the public procurement contract shall be concluded with the economic operator **IAI industrial Systems B.V.** 

Accordingly, PSA notifies **IAI industrial Systems B.V.** about the obligation to present:

1. The Performance security (5% of the contract amount without VAT), according to the provisions of art. 68 para. (8) of Law no. 131/2015 on public

procurement and tender documentation, otherwise, in case of failure to present the performance security or refusal to sign the awarded contract within the term established in the tender documentation, PSA will retain the bid security.

2. The Self-declaration regarding the *Confirmation of the identity of the actual beneficiaries* (*natural persons*) and their non-qualification in the situation of conviction for participation in the activities of a criminal organization or group, for corruption, fraud and/or money laundering, within 5 days after the date of communication of the results of the public procurement procedure (to the contracting authority and the Public Procurement Agency).
