## STATEMENT OF FULFILING RAL STANRAD

Dear Sirs,

Please be informed that CONTENUR is certified by independent, accredited certification body, TÜV SÜD, for mandatory European standard EN-840 as well for voluntary local German standard RAL GZ 951/1. This is stated in currently valid certificates as well on the certification authority's database.

CONTENUR, to prove conformity with mentioned standards, has decided to use the services of an independent, external certification body TÜV SÜD Product Service. TÜV SÜD Product Service (founded in 1866) is a globally recognized independent organization in product certification. It is endorsed by the German official accreditation body DAkkS (Registration number D-PL 11321-01-01) for certification in accordance with the applicable regulations for municipal solid waste containers. DAkkS (Deutsche Akkreditierungsstelle) is the only state accreditation body in the Federal Republic of Germany entitled to confirm the right to certification and the validity of the certificates.

GGAWB, Gütegemeinschaft Abfall und Wertstoffbehälter eV, is a private association of only some of German manufacturers. As private association is not entitled to confirm the right to certification, validity of any certificates and ways of marking the containers. In the DAkkS database containing authorized (accredited) entities for testing and certification, you will not find GGAWB.

CONTENUR is a leading manufacturer and service provider of containers for municipal waste collection and recycling and active in over 50 countries worldwide (<https://www.contenur.com>). As a professional market player being active in the business for many years, we are fully compliant with all relevant laws and regulations.

Certificate TÜV SÜD is independent, external proof of comply with the quality requirements of "EN 840" and "RAL GZ 951/1" standards by Contenur containers. Based on regularly carried audits, TÜV SÜD certifies that all quality procedures resulting from the mentioned standards are sustained and used during production of our containers as well as all assessment criteria used in the audit process are in line with standards guidelines. As a result of it, each Contenur container, according to the standards, is marked with relevant quality mark GS. The GS or "Geprüfte Sicherheit" mark is certification mark applied to finished products that signifies their compliance with all of the statutory requirements of the German Product Safety Act (ProdSG).




This mark confirms compliance with the RAL standard requirements to the same extent and degree as the quality marks of other certification bodies.

Each of the accredited certification bodies have it won marking confirming that container is produced according the specific standards. Requiring specific quality mark on the container for the same standard is a significant violation of the law of free and fair competition. It significantly limits access to a large part of the best products available on the market.
