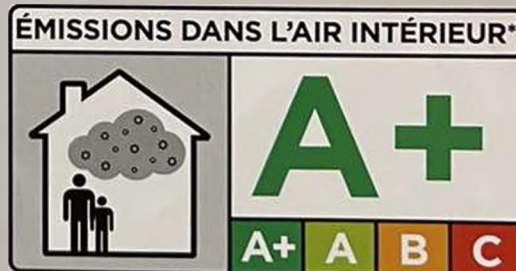

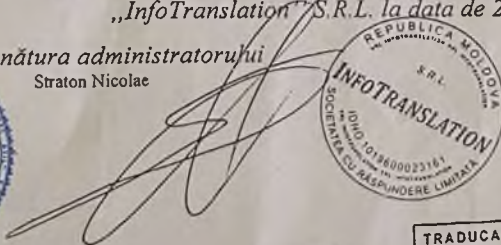

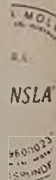

Such disclaimer shall also include the third-party repair without our authorisation of a piece that may be identified as non-compliant by factory default and the alteration of the finished product by the application of paint or another layer of coating, unusual wear, accidental deterioration, etc.

In case of any defect whatsoever, the client shall take all protective measures for the common interest of the parties.
