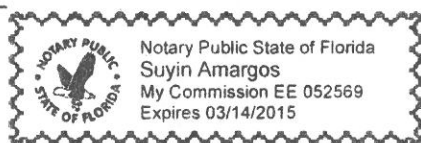



COURSE CREDIT/UNIT VALUE:

Starting January 1, 1998, Newport University began a transition to the semester unit system. Some transcripts remain on the quarter unit system. Three (3) credits signify semester units. Each semester unit of credit represents the equivalent of fifteen (15) hours of classroom study, plus additional outside preparation appropriate to the subject matter of the specific course offering. Five (5) credits signify quarter units. Each quarter unit of credit represents the equivalent of ten (10) hours of classroom study, plus additional outside preparation appropriate to the subject matter of the specific course offering.

COURSE NUMBERING AND CLASSIFICATION:

The first digit of the course number indicates the year level of the course: 100, first year undergraduate; 200, second year undergraduate; 300, third year undergraduate; 400, fourth year undergraduate; 500, graduate core courses; 600, graduate electives courses, 700, postgraduate (Doctoral) courses.

TRANSFER CREDIT:

Newport University accepts transfer credit from appropriate institutions.

GRADING SYSTEM:

The following grades are used: A, outstanding performance; B, above average performance; C, average performance; D, below average performance; F, failure. A system of grade points is used to determine a student's general average standing. Grade points are assigned to grades as follows for each unit in the credit value of a course: A, 4 points; A-, 3.7 points; B, 3 points; C, 2 points; D, 1 point; F, 0 points. Some transcripts may list CR for Credit and NC for NO Credit. CR undergraduate "C" or better, and CR graduate "B" or better.

DEGREE REQUIREMENTS:

Undergraduate students must complete a minimum of 120 units, with a grade point average of C or better (2.0), including General Education Requirements. Graduate students must complete their respective degree programs with a grade point average of B or better (3.0). Quarter Units: Undergraduate students must complete a minimum of 180 quarter units, with a grade point average of C or better (2.), including General Education Requirements. Graduate students must complete their respective degree programs requirements with a grad point average of B or better (3.0).

MAINTENANCE OF RECORDS:

The University maintains student files for 5 years and maintains transcripts for 50 years.
