

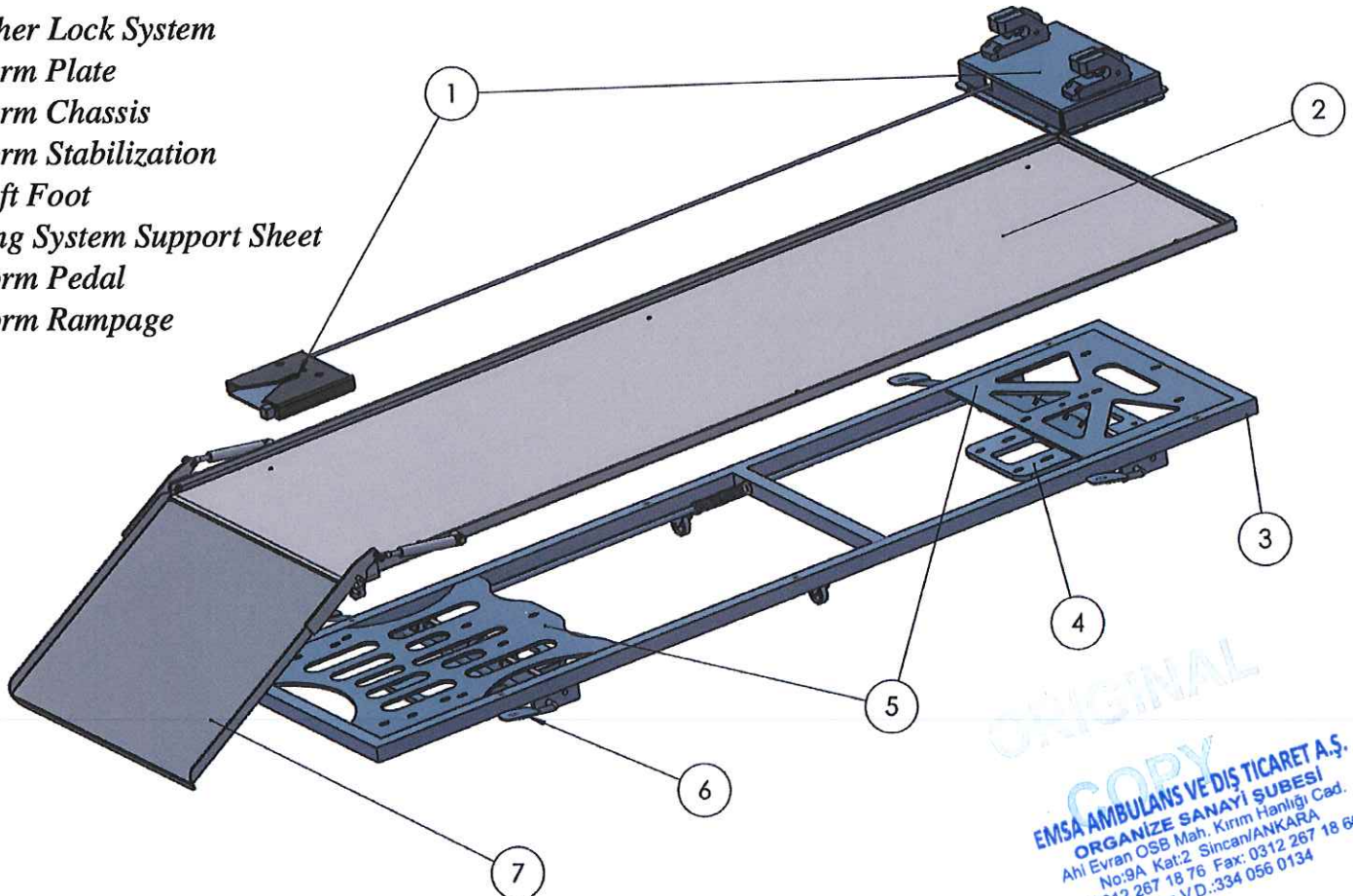
Two Directional Movement Platform EP-SM

- Metal parts are painted with electrostatic paint.
- Right - left movement 30 cm.
- There are 6 levels in total. 5 cm between levels.
- 10g Tested.

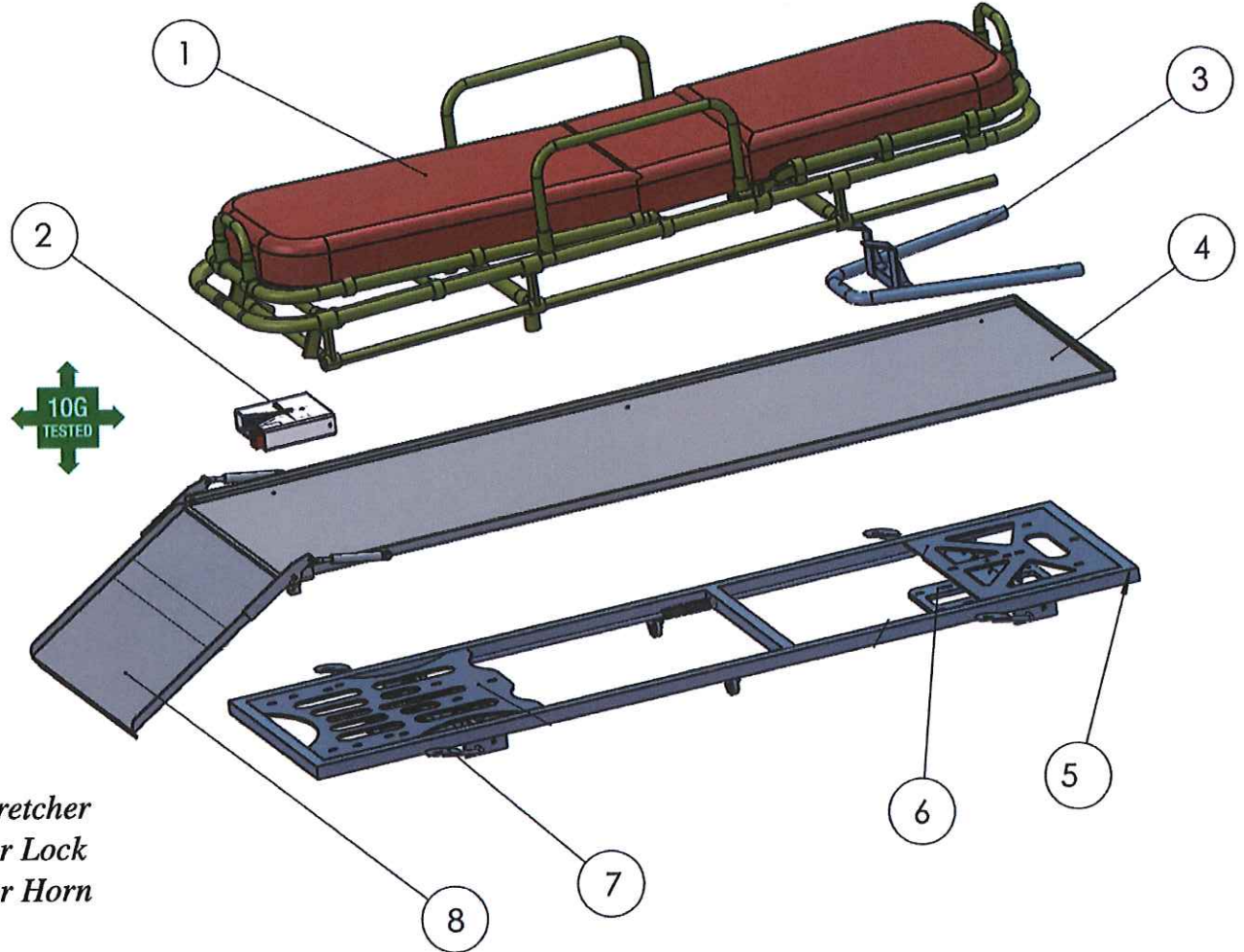
Stretcher Platform is Combination of Following Items ;

- 7- Platform Rampage

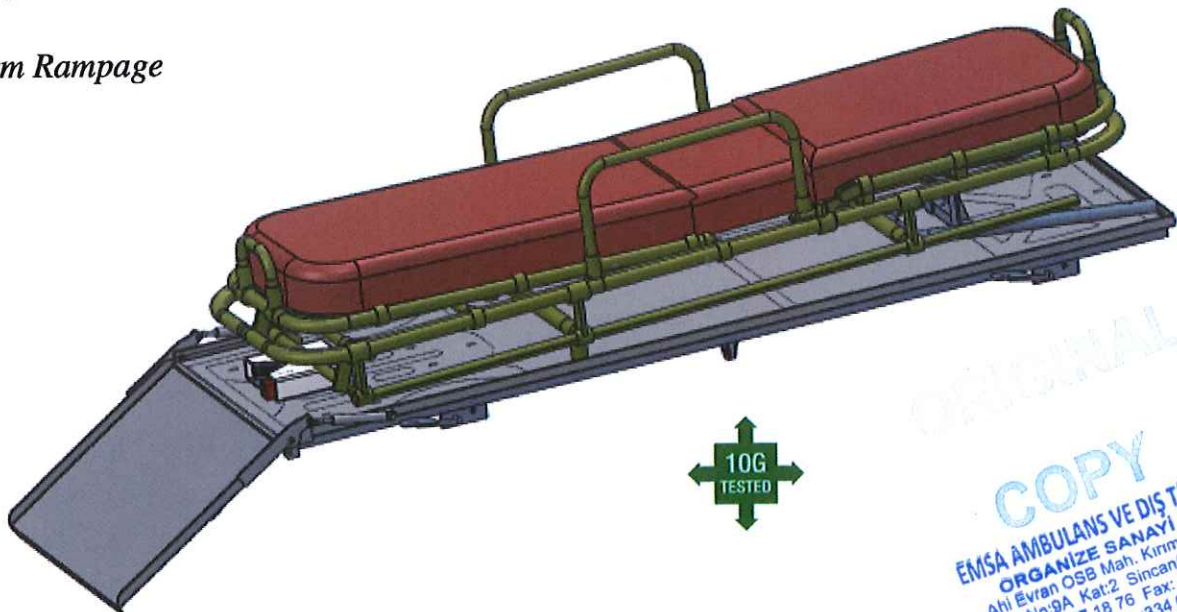
