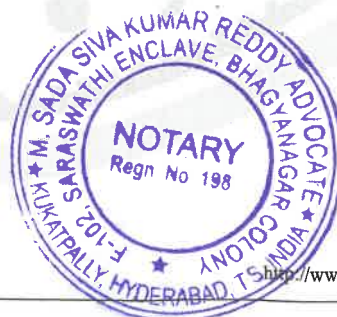

Explanatory notes
