



- 8.1. Silicate enamel titanium coating of white colour is made on the basis of PE Frit CC Wh Ti 2018 frit grade.
- 8.2. Silicate enamel titanium coating of "granite" colour is made on the basis of PE Frit CC Wh Ti 2018 frit grade – 100% and FPO YAS 200A frit grade – 15%.
- 8.3. Silicate enamel titanium coating of black colour is made on the basis of PE Frit CC Tr AR 1119 frit grade – 100% and PE Pigment Black FK 3031 SP ceramic pigment – 8%.
- 8.4. Silicate enamel titanium coating of brown colour is made on the basis of PE Frit CC Tr AR 1119 frit grade – 100% and ceramic pigment No. 260951 – 8%.
- 8.5. Silicate enamel titanium coating of "milk" colour is made on the basis of PE Frit CC Wh Ti 2018 frit grade – 80% and PE Frit CC Selfcol FPTC201 frit grade – 20%.
- 8.6. Silicate enamel titanium coating of "Marble" color is made on the basis of the ESP frit grade 95-100% , with the addition of "grains" of the following frits: ESP 200 – 25%, B 3772 – 15%, 2510 – 15%;
