3. Manufacture

Vliwasoft® Nonwoven Wound Dressing, sterile is produced according to specification in hygienic conditions and packed as described in their relevant packaging specification.

4. Description

Vliwasoft® Nonwoven Wound Dressing, sterile is a white, soft, absorbent universal compress.

5. Properties

Vliwasoft® Nonwoven Wound Dressing, sterile is made from fine-pored, non-fraying nonwoven material, for a gentle wound cleansing and has good absorption properties. The non-fraying nonwoven material is highly absorbent and is appreciated for its low-adherent properties.

Indications

- for wounds with low to moderate amounts of exudate
- as a wound dressing
- for wound cleansing
- as a carrier material for ointments
- as a padding material between fingers and toes

6. Intended purpose

Vliwasoft® Nonwoven Wound Dressing is intended to be used for cleansing and for wound care.

7. Medical device classification

Vliwasoft® Nonwoven Wound Dressing, sterile is a medical device of class Is according to rule 4. (Council Directive 93/42/CEE and Regulation 2017/745)

8. Biological evaluation and biocompatibility (DIN EN ISO 10993)

The starting materials used in the manufacture of Vliwasoft® Nonwoven Wound Dressing, sterile are safe if the product is used appropriately.
