

TERMS OF REFERENCE
for the procurement of visibility materials within the Project “ROMD00024
(C-TRAINED) Cross border joint training”,
Customized Power Bank

1. General Information

1.1. These Terms of Reference form an integral part of the procurement documentation and represent the set of requirements based on which each bidder prepares their technical proposal (offer).

1.2. The Terms of Reference include technical specifications and basic rules that must be observed so that potential bidders can prepare their technical proposal (offer), as well as rules that must be followed during the implementation of the awarded contracts.

1.3. The technical specifications of the products define, as applicable and without limitation, characteristics related to quality level, technical and performance features, operational safety, dimensions, quality assurance systems, symbols, tests and laboratory tests, testing methods, packaging, labeling, marking, and conditions for certifying compliance with relevant or similar standards.

1.4. Within this procedure, The Căușeni Regional Directorate for Exceptional Situations of the General Inspectorate for Emergency Situations of the Ministry of Internal Affairs acts as the Contracting Authority and Buyer based on the contract.

2. Objective of the Procurement

2.1. The objective of these Terms of Reference is the procurement of visibility materials within the Project “ROMD00024 (C-TRAINED) Cross border joint training” — customized power banks, according to the quantities and values indicated below.

3. Technical Qualification Criteria

3.1. The technical specifications attached to these Terms of Reference represent the minimum requirements regarding quality, technical performance, and functionality, and the solutions proposed in technical offers may refer to achieving higher standards.

3.2. Failure to comply with the minimum technical requirements or incomplete fulfillment of the general and specific characteristics will lead to disqualification and rejection of the offer.

3.3. Deviations from the requirements of these Terms of Reference are not accepted. Exceptionally, any offer that deviates from the requirements will be considered only if the technical proposal ensures a higher quality level than that required by the Contracting Authority.

In such a case, the bidder must clearly indicate the superior characteristics in the technical proposal and provide supporting documents proving the higher quality level compared to the authority's requirements.

3.4. The technical proposal must be drafted in a manner that clearly corresponds to the requirements of the Terms of Reference and the product's technical specifications (an integral part of this document).

3.5. All documents in the technical proposal must be valid at the submission deadline and certified as authentic copies by applying the stamp and authorized signature of the bidder.

3.6. The warranty period for the offered products must be at least 24 months from the date of delivery.

4. Final Requirements

4.1. The Supplier is fully responsible for delivering the products in the quantities specified in the procurement contracts for material goods. The Supplier is also responsible for the safety of all delivery operations and methods.

4.2. If, during the warranty period, a product fails to meet the quality for which it was designed, the supplier must replace the item at their own expense. The replacement of non-compliant or warranty-covered products will be ensured entirely by the supplier.

4.3. The Contracting Authority reserves the right to request the free replacement of product quantities that fall within the warranty period and whose technical parameters or compliance do not meet the product's technical specifications.

4.4. All documents forming the technical proposal, as requested by the Contracting Authority through the Procurement Documentation, must be in Romanian or, if issued by institutions/laboratories from other EU states, must be accompanied by translations into Romanian.

1. GENERAL INFORMATION

1.1. The subject of these technical specifications is the procurement of **175 customized power banks**, used as visibility materials within the Project “ROMD00024 (C-TRAINED) Cross border joint training”, by the Causeni Regional Directorate for Exceptional Situations of the General Inspectorate for Emergency Situations of the Ministry of Internal Affairs.
