



1- Product

1.1- Presentation

Single-use wash glove with an inner layer, pre-moistened with a no-rinse body wash lotion particularly suitable for bathing elderly patients, bedridden, incontinent or dependent patients.

1.2- Description

- Glove: non-woven: 90 g/m², 3D embossed, 40% viscose, 60% PET, lined with inner PE 20µ layer
 - Lotion : Ingredients : AQUA, GLYCERIN, POTASSIUM SORBATE, LACTIC ACID, SODIUM BENZOATE, DIMETHICONE, DECYL GLUCOSIDE, POLYGLYCERYL-4 CAPRATE, SORBITAN CAPRYLATE, CAPRYL/CAPRYL GLUCOSIDE, DISODIUM COCOAMPHODIACETATE, SODIUM CHLORIDE, DISODIUM EDTA, ALOE BARBADENSIS LEAF JUICE, HYDROGENATED ETHYLHEXYL OLIVATE (AND) HYDROGENATED OLIVE OIL UNSAPONIFIABLES, PANTHENOL, TOCOPHERYL ACETATE, BISABOLOL, PARFUM, CITRONELLOL, LINALOOL.

1.3- Characteristics

Aqua TOTAL HYGIENE Wash Gloves are moistened with a cleansing and moisturizing lotion, formulated with protective and moisturising active ingredients.
 The lotion does not contain alcohol or soap and has been dermatologically-tested (2 tests performed): Patch test (irritation cutanée), ophthalmological test (eye irritation).

2- Conditions of Use

2.1- Instructions for use

- 1- Open the pack.
- 2- For more comfort, the gloves can be heated in the microwave oven before use, according the instructions:

Gloves	12-9	10-5	4-2	1
Indication	700W - 15s	700W - 10s	700W 15s	700W 10s

- 2- Take one glove and slide hand inside and close the pack.
- 3- Wash skin according to currently applicable bathing protocol. The product does not require any rinsing.
- 4- The lotion dries on skin and forms a protective layer. Product does not require to be dried.

2.2- Disposal

Do not dispose into the toilets. Dispose according to currently applying protocols in force: dispose into regular waste or in hazardous waste disposal if required.

2.3- Precautions

Single-use product. Do not use more than one time.
 Do not use on damaged skin. In case of infectious risks, use one pack of gloves for one single patient. Rinse thoroughly the eye in case of contact or the mouth in case of ingestion. If in doubts, call a doctor.
 Keep in a dry place, away from light and heat.

3- Regulation

3.1- Conformity

Complies with European regulation (CE) n° 1223/2009 on cosmetic products.

3.2- Identification

Each product is identified with a lot number, an expiry date and a period after opening (3 months).

3.3- Customs Code
