

Warranty Certificate.

Unless otherwise provided in a written warranty statement delivered by **MSA** with the Products, or on its website, or in a binding contract signed by an authorized representative of **MSA**, the following warranty (“Warranty”) shall apply to purchases of Products hereunder: **MSA** warrants to the original end user only that the Product shall, for a period of **(2) year** from the date of original purchase (the “Warranted Period”), be free from defects in workmanship and material under normal recommended use and service, as outlined in **MSA**’s instruction manual and maintenance requirements, including those prescribed by applicable approval and regulatory agencies (the “Use and Maintenance Requirements”).

During the Warranted Period, **MSA** shall repair or replace, at its option, any Product, or part thereof, found to fail to meet this Warranty. The Warranty shall not apply to any damage or failure resulting from non-compliance with the Use and Maintenance Requirements, misuse, abuse, misapplication, improper installation, improper operation, negligence, accidental damage, mechanical, electrical, or environmental circumstances, normal wear and tear of parts, or other defects not related to workmanship or material. Any unauthorized repair, modification, or adjustment of the Product completely voids this Warranty. Expendable, disposable, and consumable parts are warranted at delivery only. **MSA** extends no other warranty. **MSA** makes no warranty for any third party products or components (those manufactured by any party other than **MSA** and its affiliates). Customer’s sole remedy for any third party product claims is the original manufacturer’s warranty, which **MSA** agrees to pass on to the Customer upon request. No Product removal, installation, or transportation charges are covered under this Warranty. Repairs or replacements shall not interrupt or extend the Warranted Period. The Warranty for each Product must be registered with **MSA** within thirty (30) days of purchase.
