[HA724 trade name], manufactured at MSN Laboratories Private Limited, Rangareddy District, Telangana, India, was included in the WHO list of prequalified medicinal products for the treatment of HIV on 01 March 2022.

[HA724 trade name] is indicated for HIV treatment. Detailed information on the use of this product is described in the summary of product characteristics (SmPC), which can be found in this WHOPAR.

The active pharmaceutical ingredient of [HA724 trade name] is darunavir.

The efficacy and safety of darunavir are well established based on extensive clinical experience in the treatment of HIV.
