We, the undersigned, BC ProCredit Bank S.A., Bd. 65 Ștefan cel Mare și Sfint blvd., of. 901, MD-2001, Chișinău, Republic of Moldova (hereinafter called "the Guarantor"), hereby irrevocably declare that we will guarantee as primary obligor, and not merely as a surety on behalf of DALU MOL SRL, str. Academician Sergiu Răduțanu nr. 9, ap. 54, Chișinău, Republic of Moldova, IDNO 1013600007534, (hereinafter called "the Tenderer") the payment to the contracting authority of 210 EUR, this amount representing the required guarantee under the tender participation announcement No. ocds-b3wdp1-MD-1769524125899, public tender nr. 21556983 from 27 of January 2026 .

Payment shall be made without objection or legal proceedings of any kind, upon receipt of your first written claim (sent by registered letter with confirmation of receipt) in which you simultaneously confirm that the Tenderer is in breach of its obligation(s) under the Tender conditions, because the Tenderer:

- (a) has withdrawn its bid during the period of Tender validity specified by the Tenderer in the Letter of Tender; or
- (b) having been notified of the acceptance of its bid by the Employer during the period of Tender validity, (i) fails or refuses to execute the Contract Form, if required, or (ii) fails or refuses to furnish the performance security, in accordance with the Tender Document.

We shall not delay the payment, nor shall we oppose it for any reason whatsoever. We shall not under any circumstances benefit from the defences of the security.

This guarantee will expire: (a) if the Tenderer is the successful Tenderer, upon our receipt of copies of the contract signed by the Tenderer and the performance guarantee issued to you upon the instruction of the Tenderer; and (b) if the Tenderer is not the successful Tenderer, upon the earlier of (i) our receipt of a copy of your notification to the Tenderer with the name of the successful Tenderer; or (ii) 45 days after the period of tender validity, which is 14.05.2026.

Our guarantee will be reduced by each payment made by us as a result of a claim.

Any demand for payment under this guarantee must be received by the Guarantor on or before the expiry date.

Guarantee expires in full and automatically, irrespective of whether the present document is returned to us or not.

This guarantee is personal to yourselves and is not transferable or assignable. The law applicable to this guarantee shall be that of Republic of Moldova.

The guarantee will enter into force and take effect from the date of its issuance.
