STANDARD FORM OF THE SINGLE DOCUMENT OF EUROPEAN PROCUREMENT

- 1. The Single European Procurement document (hereinafter, the ESPD) is a self-declaration by which the economic operator confirms the fulfillment of the qualification and selection criteria required in public procurement procedures in the Republic of Moldova.
- 2. The form shall be completed, signed electronically and transmitted to the contracting authority upon submission of the tender.
- 3. A UAD submitted by the economic operator in the context of a previous public procurement procedure may be reused, provided that the information contained in the form is correct and valid at the time of its submission.
- **4.** The economic operator who presents false information or supporting documents in the DESPD does not confirm the information indicated in the submitted document is excluded from the public procurement procedure and/or can respond in accordance with the legislation.
- **5.** The ESPD form consists of 7 chapters, namely:
- 1) Chapter I. Information on the public procurement procedure and the contracting authority/entity;
 - 2) Chapter II. Information relating to the economic operator;
 - 3) Chapter III. Grounds for exclusion from the public procurement procedure;
 - 4) Chapter IV. The criteria for the qualification and selection of economic operators;
 - 5) Chapter V. General indications for the criteria for the selection of economic operators;
- 6) Chapter VI. Pre-selection of candidates for the procedure for awarding the public procurement contract;
 - 7) Chapter VII. Final declarations.
- **6.** The submission of the ESPD form when submitting the tender which does not comply with the requirements set out in the tender documentation shall lead to the rejection of the tender.
