DISTRIBUTION AGREEMENT

BETWEEN THE UNDERSIGNED:

Spineart SA, a limited liability company having its head offices located 3 Chemin du Pré-Fleuri; 1228 Plan-les-Ouates; Switzerland, registered with the Commercial and Trade Register of Geneva under the federal number CH-660-1013005-1,

Represented by Mr. Stéphane Mugnier

Hereinafter referred to as "**Spineart SA**";

ON THE FIRST HAND,

AND:

ORTOFIX, a corporation having its head offices located at Str Mt Gurie Grosu 15/4 2028 Chisinau; Moldova represented by Roman Bolocan duly authorized for the present purposes,

Hereinafter referred to as the "**Distributor**";

ON THE SECOND HAND,

Hereinafter referred to individually as a "Party" and collectively as the "Parties",

THE FOLLOWING HAS PREVIOUSLY BEEN DECLARED:

Spineart SA is specialized in the designing, manufacturing and marketing of medical devices for the spinal surgery. Being the owner or exclusive user of a certain number of patents and brands, Spineart SA distributes its products in Switzerland and abroad under its trademark Spineart SA and other brands depending on the products.

This exploitation requires the respect of international standards such as EC markings according to European Directive 93/42 and the ISO certification 9001:2008 and ISO 13485:2003, specially qualified staff and logistic means (including but not limited to: place of storage, transportation, product follow-up devices) specially adapted.

It has become necessary to organize the marketing of these products within a network of distributors combining these qualities. The implementation of such network is indispensable for the development of products which themselves necessitate specific marketing methods in accordance with quality requirements in the medical sector.

Consequently, Spineart SA has decided to entrust the exclusive distribution of certain products to specialized distributors who will be in charge of selling the products in a given territory.

The Distributor is specialized in the sale of medical devices, notably implants devised for surgery of the spine. As a result of this activity, it possesses a specially qualified staff and logistic means (including but not limited to: place of storage, transportation, product follow-up tools) specially adapted. Some documentation describing the activity of the Distributor is attached in Appendix 6.

After being informed of the mutual obligations of the Parties, the Distributor wishes to obtain the title of exclusive distributor of Spineart SA products. In return Spineart SA wishes to grant such title to the Distributor.

Therefore, the Parties have agreed to develop their relationships on the basis of the terms of the Contract, pursuant to the terms and conditions set forth in the Contract.

IT HAS THEREFORE BEEN AGREED ON THE FOLLOWING:

Definitions:

1. **"Brands"** shall mean the brands, trademarks, names of Products including Spineart SA corporate identity symbols (logos) registered with accredited national and international bodies such as INPI and OMPI as well as any other names used by Spineart SA;
2. **"Client(s)"** shall mean a surgeon or an hospital as well as a clinic, private or public, including any sub distributor or wholesaler;
3. **"Contract"** shall mean this Distribution Agreement and its Appendices;
4. **"Intellectual Property"** shall mean the intellectual property rights on patents, brands, product names, designs, models held by Spineart SA relative to Products;
5. **"Product(s)"** shall mean finished one or several products manufactured and/or commercialized by Spineart SA as listed in Appendix 1 (the list of Products); this Appendix 1 does not include all the products manufactured, marketed and commercialized by Spineart SA, and nothing herein shall be construed to require Spineart SA to sell such other products to Distributor;
6. **"Sub-distributor(s)"** shall refer to any Sub-distributor to whom Distributor is entitled to entrust the distribution of Products according to the provisions of the Contract;
7. **"Territory"** shall mean the geographical zone covered by the Contract as described in Appendix 2.

Article 1 Purpose

The Contract shall define the general conditions of the collaboration between the Parties and more particularly, the supplying conditions of Products to Distributor by Spineart SA, the distribution, the marketing, the commercialization, the promotion of Products in the Territory and the mutual obligations of the Parties in the carrying out of the Contract.

Article 2 Appointment – Assigning of rights – relations between the Parties

- 2.1 Spineart SA hereby assigns to Distributor, subject to the terms and conditions of the Contract, the exclusive right to market and sell the Products to the Clients in the Territory, eventually through Sub-distributors in the conditions set forth in the Contract. Subject to the terms of this Contract, such modification to "Territory" or to the list of Products will be the object of a written amendment to the Contract.

The Distributor shall obtain supplies under the Spineart SA trademark exclusively from Spineart SA for the purchase of Products that it shall market and sell to the Clients in the Territory.

The Distributor shall respect the exclusivity assigned by Spineart SA to other distributors and shall refrain from developing outside the Territory an active sales policy through any means whatsoever, through advertising or promotional actions, through the Internet or through the establishment of a sales point. Subject to the terms of this Contract, Spineart SA agrees not to directly or indirectly or through third parties other than the Distributor, sell the Products in the Territory.

In the case where Distributor is contacted directly by a customer situated outside the Territory, in absence of any doorstep selling, he should immediately inform Spineart SA.

Except for these products listed in Appendix 8, Distributor undertakes, for himself and on behalf of its Sub-distributors, to distribute no other products potentially competing Products,

More generally, the other products marketed by the Distributor shall not harm the marketing of Products.

Spineart SA may, from time to time, make any changes in the composition, nature and labeling of any Product as it shall deem necessary or desirable, or, at any time, delete or cease to sell any Product from the list of Product. Such deletion of any Product shall not be interpreted by the Distributor as termination, even partial, of the Contract. Spineart SA undertakes to notify the Distributor of any changes in or deletion of the Products at least (six) 6 months in advance.

Spineart SA may also commercialize or sell in the Territory, directly or with another distributor, any other product which is not on the list of Products, as well as offer the Distributor to sell such other products, being understood this offer cannot be construed as an obligation for neither Spineart SA to sell such other products to Distributor nor for the Distributor to purchase and sell such other products. If and when the Parties agree on sale of such new products, those shall be added to the list of the Products pursuant to a written agreement to be concluded between the Parties to that effect.

Distributor acknowledges and agrees that Spineart SA may give or sell Products directly to Clients or customers in the Territory only for special activities such as clinical trials, product evaluation, or product development.

2.2 Spineart SA also grants Distributor, who accepts, a license, for the duration of the Contract, to utilize the Brands on the Territory for the promotion, distribution and sale of Products.

2.3 The exclusivity is granted by the Contract as far as the Distributor can attain the objectives set between the Parties; thus, also pursuant to article 5.4, in the case where the Minimum half year turnover has not been attained Spineart SA may terminate said exclusivity, upon two (2) weeks prior notice to the Distributor.

If the Minimum half year turnover has not been attained by the Distributor Spineart SA may instead modify the Territory and/or the list of Products upon 2 weeks prior notice to the Distributor.

2.4 The Distributor will buy and sell the Products under its own name and on its own account. The Contract cannot be assimilated to a "**relation d'agent**" or an employment contract between the Parties.

Subject to the provision of article 10.6, it is agreed that Distributor shall be entitled to entrust the distribution of the Products in parts of the Territory to one or more Sub-distributors, provided that each said Sub-distributor is bound up with all the obligations applicable to and the undertakings taken by the Distributor, as if the considered Sub-distributor had signed the Contract as Distributor, except for the provisions of article 3 here under.

Thereby, Distributor will endorse the responsibility to collect a contractual undertaking from each Sub-distributor to conform to the provisions of the Contract, and to provide the Sub-distributor with a copy of the Contract duly annexed to say contractual undertaking.

Distributor shall report upon Spineart SA's request the identities and the description of the territory, the resources and the activities of the Sub-distributors. This reporting shall be updated annually when Parties shall meet to define the objectives in terms of Minimum half year turnover to be attained for the coming year, according to article 5.4 here under.

Spineart SA shall be entitled, within a one (1) month period as from the receipt of said reporting, to refuse any contemplated sub-distributor other than the Sub-distributor whose title is given above among the parties to the Contract. In such a case, Distributor shall refrain to entrust such sub-distributor with the distribution of any of the Products.

The Distributor shall defend by any means Spineart SA from any prejudice Spineart SA could suffer from any non-conformity to the Contract imputable to any Sub-distributor.

Any Sub-distributor shall be directly liable towards Spineart SA according to any obligation or undertaking taken by Distributor in the Contract. It is agreed that Spineart SA shall be entitled to present claims or sue directly any Sub-distributor who does not conform to the provisions of the Contract.

The Products delivered shall always be paid by Distributor to Spineart SA notwithstanding the Distributor's choice to call on Sub-distributors, Spineart SA undertakes to refrain from accepting direct orders from Sub-distributors, provided that Distributor conforms to the provision of the Contract and notably set forth in articles 5 and 10.

Article 3 Duration

The Contract will enter into effect on the Signature date of the Contract and shall remain in effect until the 31st of December 2022. However, during the first year, it can be freely terminated by either party subject to a notice period of seventy-five (75) days.

At the end of this period, the Contract will be renewed by tacit agreement for successive two-years periods except in case of termination to be freely notified by either of the Parties by registered letter with record of receipt ninety (90) days before the date of renewal. Such notification entails automatically the termination of the exclusivity granted to the Distributor on the Territory.

The Contract can also be terminated pursuant to the provisions of article 10 and also at any time if the Distributor does not comply with the Minimum half year turnover provided herein after, pursuant to articles 2.3, 5.3, 5.4 and 10.2.

Article 4 Purchase – Sale and resale of the Products

4.1 The orders shall be registered and processed according to the terms and conditions of the Contract as well as the general sale conditions of Spineart SA. The general conditions of the Distributor will not be binding as against Spineart SA. Any modification of the terms and conditions of the Contract by Spineart SA as well as of its general sales conditions will be effective for any future orders, thirty (30) days after their notification to the Distributor.

4.2 Distributor shall provide to Spineart SA a six (6) month advance sales forecast, at the end of each calendar quarter.

4.3 Distributor agrees to pass all orders to Spineart SA in writing. The latter will provide an acknowledgment of receipt of each order six (6) business days at the latest following receipt of same. When exceeding an amount of 30'000 Euros (Thirty Thousand Euros) per order, Spineart SA may request for particular guarantees of payment from the Distributor. When an order is confirmed, Spineart SA shall make its best efforts to process and deliver the Products within a delay of six (6) weeks as from receipt of the order. Said delays are for indication purposes only and Spineart SA shall not be responsible for loss or damage suffered by the Distributor or any third party as a result of delays in delivery of accepted orders.

No accepted and confirmed purchase orders shall be modified or cancelled by both Parties, including cases of deletion of certain Products.

4.4 The Parties to the Contract hereby agree that the applicable prices shall be the Spineart SA prices in force the day of the order. Said prices are attached in Appendix 1 of the Contract. Prices shall be reasonably updated by the Parties on anniversary dates of the Contract. Except case described here after, prices should not exceed an increase of 3% per annum. Such update shall be made at the latest on each 30th of September. Price update should be applicable on anniversary dates of the Contract. Notwithstanding the above, should the production costs increase more than 10% over a six (6) months period, the Products prices shall be reasonably updated by the Parties at their earliest convenience.

Previous prices shall remain into force until an agreement is reached. Parties shall procure their best efforts to find this agreement.

4.5 The Products are billed Ex Works (EXW).

4.6 The entirety of the risks incurred by the Products is transferred to the Distributor (or its Sub-distributors) upon delivery of said Products to the forwarding agent (EXW). The Distributor shall be responsible for securing the insurance to cover risk of loss to the Products during shipment.

4.7 Invoices are issued and payments are made in Euros, and pursuant to the conditions mentioned on the invoice. The amount of the invoices and their payments are to be considered without set-off or counterclaim and free and clear of and without deduction for any other charges of any kind. The Products prices do not include insurance, freight, customs duties, taxes and other similar charges, which shall be the responsibility of the Distributor. All exchange, interest, banking collection and other charges shall be at the Distributor's expense.

4.8 For the first order, the minimum amount and the payment terms are specified in clause 5.3. For subsequent orders payment conditions are 100% before delivery.. The execution of orders is therefore subject to the payment conditions by the Distributor.

The decision of Products delivery postponement by Spineart SA shall not require prior written notification to the Distributor. However, Spineart SA agrees to notify the Distributor of such a decision by no later than six (6) business days following its first rejection of supply.

4.9 The transfer of title to the Distributor of Products delivered is subject to the effective payment of the whole price, in principal, interest and accessory, within the agreed term.

In case of non-payment on the agreed settlement date and two days after unsuccessfully serving notice, Spineart SA may request immediate restitution of Products at the Distributor's expense.

- 4.10 The Distributor (or its Sub-distributors) shall be free to set his own resale prices of Products on the Territory. Said prices should be competitive and respect the legislation in force. However, Spineart SA may provide the Distributor with a sample pricelist, which applies in the Territory and complies with the reputation and market positioning of the Products. In the case the Distributor call on Sub-distributor(s), the Distributor shall ensure that the resale prices practiced by the Sub-distributor(s) comply with these requirements.

Article 5 Overall obligations of the Distributor

- 5.1 The Distributor agrees to take the necessary steps to register, apply for, obtain and maintain fully administrative or other authorizations or licenses necessary to import, export, promote, market, use and sell the Products on the Territory. The Distributor shall be solely responsible for respecting the legislation in force on the Territory with regard to the importation, exportation, promotion, marketing, distribution, commercialization, or use of Products. This commitment concerns notably markings of the Products or their packaging, or translations in language of end customer.
- 5.2 In this respect, the Distributor agrees to identify one or further individuals in its organization (or its Sub-distributors) who is knowledgeable of regulatory requirements applicable to the Products in the Territory and who will serve as primary contacts for regulatory matters, including filing of requested license or authorizations, obtaining and maintaining, as applicable, such regulatory approvals for the Products in the Territory.

The registration of administrative authorizations shall be recorded in the name of Spineart SA, except when absolutely impossible under applicable law.

Regardless of the Distributor (or one of its Sub-distributors) being the holder of the administrative authorizations of Products due to requirements under applicable law, the beneficial owner of such authorizations shall be exclusively Spineart SA and in any event the Distributor hereby renounces irrevocably, for himself and on behalf of any of its Sub-distributors, to make any personal usage of them, renting them out free or for compensation, or loaning or licensing them, except for the utilization he will make of said authorizations throughout the term of the Contract. Upon the expiration, cancellation, or termination of this Contract, if the Distributor (or one of its Sub-distributors) has registered any authorizations on its name, he shall take all necessary and reasonable actions to transfer and deliver such registrations, approvals and/or licenses (including any Product names, trade names and trademarks) to Spineart SA, to the extent that this is permissible under applicable law, at no cost to Spineart SA.

The Parties will work together in good faith in duly and timely providing relevant documentation for the completing of application files to the relevant authorities in the Territory in view of obtaining the regulatory approvals for the Products in the Territory.

The Distributor (and its Sub-distributors) shall not make any representation or filing with respect to any Product to any government or regulatory agency without first obtaining Spineart SA's prior written approval. The Distributor shall provide Spineart SA with a follow-up of the procedures in the Territory, and notify Spineart SA of all permits; approvals and registrations obtained by it and shall provide Spineart SA with copies of all material documents related thereto.

The Distributor undertakes irrevocably, for himself and on behalf of any of its Sub-distributors, not to do anything that could harm the obtaining of administrative or

regulatory authorizations or the maintaining of administrative or regulatory authorizations by Spineart SA.

- 5.3 The Distributor hereby makes the irrevocable commitment, for the year 2021, (and on the assumption that the Contract will remain in force following the first year), 2022 to order and pay a minimum quantity of Products from Spineart SA corresponding to the Minimum half year turnover requirements, as mentioned in Appendix 3. The first half year period during which this minimum requirement is applicable shall begin on the latest 1st of February 2021.

On the assumption that the Contract will remain in force at the time, for the year 2022 and the following years, the Parties shall meet at the latest on the 30th of September of each year, and for the first time on September 30, 2022, to define the objectives in terms of Minimum half year turnover to be attained for the coming year.

In case where half year amounts of paid orders by the Distributor to Spineart SA is inferior to the Minimum half year turnover described in Appendix 3, Spineart SA will be in a position to take the following decision:

- terminate the Contract in accordance with provisions contained in Article 10.2;
- decide, with a two (2) weeks' notice, that Distributor's exclusive right to distribute the Products in the Territory shall become non-exclusive and Spineart SA shall be entitled to appoint one or more non-exclusive distributors of the Products in the Territory at any time after the effective date of delivery of such notice;
- decide, with a two (2) weeks' notice, to modify the list of Products and/or the Territory.

- 5.4 The Distributor (and its Sub-distributors) shall store the Products according to quality standards required by the technical nature of said Products and by the standards of preservation of Products, as they are specified notably in Appendix 4.

Distributor shall also guarantee a constant control of the quality of the Products in its possession (or of its Sub-distributors), as from delivery of the Products, and the preservation enabling to maintain the characteristics of origin of Products.

Distributor will inform Spineart SA within 2 days of defaults it may find that could affect delivered Products.

- 5.5 The Distributor (and its Sub-distributors) will respect marketing standards of Spineart SA. Furthermore the Distributor (and its Sub-distributors) will market the Products within an environment and organization corresponding to the technical requirements of the Products and the image of Spineart SA.

The Distributor shall be responsible to market and promote the sales of the Products in the Territory and to process within the best delays the orders of Products or requests from Clients or prospects in the Territory.

The Distributor's requirements concerning the promotion shall include, but shall not be limited to, creating and distributing brochures, promoting the Products at conferences and exhibitions in the Territory, inciting sales representatives to sell the Products, and advertising the products in various forms of media.

At the beginning of each calendar year, Distributor and Spineart SA shall mutually agree on the sales promotion activities of the Distributor.

Any element of promotion or publicity developed by Distributor, in accordance with Spineart SA requirements, should be approved in writing by Spineart SA before use.

The entirety of promotional events will be at the Distributors expense, unless otherwise agreed by Spineart SA in writing.

The Distributor (and its Sub-distributors) shall sell the Products under the brand and in the packaging of Spineart SA. Distributor shall inform Spineart SA of the legal requirement concerning the information to be mentioned on the Products, the packaging and/or the notice of use or care, in the Territory.

Distributor shall not pass on to the Clients a guarantee or warranty or any instruction for the use or care of the Products not expressly set out in the Contract as well as in the notice of use to be given by Spineart SA to the Distributor for the respective Product.

5.6 The Distributor will order enough Products from Spineart SA in order to maintain a permanent and sufficient level of inventories to satisfy at all times and without delay customer orders in the Territory.

5.7 Through the duration of the Contract the Distributor (and its Sub-distributors) should not manufacture or have manufactured for its own account or for third parties, products dedicated to spine surgery, directly or indirectly, that would compete with the Products manufactured or sold by Spineart SA.

Through the duration of the Contract and after its termination, the Distributor (and its Sub-distributors) should not manufacture or have manufactured for its own account or for third parties, identical products to the Products and to other products manufactured or sold by Spineart SA.

Through the duration of the Contract, the Distributor (and its Sub-distributors) should not manufacture or have manufactured for its own account or for third parties, represent or sell in the Territory, products dedicated to spine surgery other than the Products and other than the products manufactured or sold by Spineart SA, except for the products listed in Appendix 8.

The Distributor (and its Sub-distributors) makes the commitment not to open a branch or warehouse for the sale of the Products outside the Territory. Any sales carried out at the Distributor's initiative (or its Sub-distributors') to a buyer outside of the Territory will result in penalties as of right due by Distributor immediately payable to Spineart SA amounting to five (5) times the price of the Products sold by Distributor pursuant to this Contract.

5.8 The Distributor shall protect the interests of Spineart SA in the Territory and will in particular provide Spineart SA with all available information necessary to acquire a good knowledge of the market and the Territory, yet without being obliged to conduct or have made independent market researches solely upon the request of Spineart SA. The Distributor shall regularly inform Spineart SA of its activities (and its Sub-distributors') and shall provide the latter with a balance sheet on a monthly basis of activities connected to the marketing and sale of the Products pursuant to the standards provided in Appendix 5. It will furthermore inform Spineart SA of any changes that may occur in its financial situation, or in the property, control or management of its company.

Distributor agrees that upon a minimum fifteen (15) days notice from Spineart SA, representatives of Spineart SA shall, during normal business hours, be permitted to visit all locations where Distributor (or its Sub-distributors) maintains inventory of Products to

conduct a quality assurance audit. In case of disagreement between the Parties in connection with the Contract, Spineart SA shall also have the right during reasonable business hours, to inspect the books and records of Distributor (or its Sub-distributors'), which are used in connection with the sale of Products, including all complaint documentation. Spineart SA acknowledges that the business of the Distributor (or some of its Sub-distributors) comprises not only sale of Products thus the Distributor (and its Sub-distributors) shall refrain from disclosing certain information or books and accounts due to its confidentiality undertakings vis-à-vis third parties.

- 5.9 Distributor shall maintain throughout the Territory an adequate sales force, that has been properly trained on the use of the Products. Distributor shall also provide any and all necessary and appropriate customer liaison services with respect to the Products to Clients in the Territory. Distributor shall promptly respond to any customer complaints or comments concerning the performance of the Products and shall promptly advise Spineart SA of all Product complaints.
- 5.10 Distributor shall not sell the Products to any other third parties than the Clients or Sub-distributors. The Distributor or any Sub-distributor is authorized to use the services of secondary Sub-distributors in the Territory provided that Spineart SA has been informed as stated in article 2.4 and has not refused the contemplated Sub-distributor.
- 5.11 For the duration of the Contract and after its termination, the Distributor (and its Sub-distributors) shall keep confidential and will not disclose to third parties any information concerning Spineart SA, the Contract, the conception and manufacturing of the Products and more generally any information that could be damaging to Spineart SA.
- 5.12 The Distributor (and its Sub-distributors) shall, as an independent merchant, take out all the necessary insurances for the exercise of its activity and notably insurance covering the consequences of its civil liability for marketing the Products on the Territory. For avoidance of doubt, existence of such insurance does not relieve Spineart SA from its obligations in relation to consumer direct claims that are strictly related to the manufacturing of the Products.
- 5.13 Distributor, and any Sub-distributor, shall pass on to Distributor's Clients the limitation of liability set forth in clause 6.4.
- 5.14 Distributor shall indemnify, defend and hold Spineart SA harmless against all claims, liabilities, costs and expenses (including the reasonable and documented fees of attorneys and other professionals) incurred by, or threatened against, Spineart SA in connection with any representation or warranty by Distributor inconsistent with the foregoing limited warranty and disclaimer and publications of Spineart SA concerning the Products.
- 5.15 Distributor shall promptly notify Spineart SA if it becomes aware of counterfeit Products in the Territory and outside, or elsewhere outside the Territory. Distributor covenants and agrees not to purchase any counterfeit products of the Products and shall not sell in the Territory products, which may be counterfeit products of the Products.
- 5.16 Distributor represents and warrants to Spineart SA the following:
- Distributor is a company lawfully incorporated and duly registered;
 - Distributor is not bankrupt;
 - Distributor has full power and authority to enter into and perform the Contract and nothing prevent the latter to sell the Products in accordance with the Contract. The Contract constitutes binding obligations on the Distributor in accordance with its terms;

- The representations contained in the Contract as well as the information provided to Spineart SA is true and correct.

In the event one of the here above mentioned statements turns out to be inaccurate or wrong, Spineart SA should be entitled to terminate the Contract without further notice, according to the conditions set forth in article 10.2.

Article 6 Overall obligations of Spineart SA

- 6.1 Spineart SA shall make its best efforts to supply and deliver the Products in conformance with their conditions of delivery, provided that the orders have been addressed by Distributor to Spineart SA at least six (6) weeks before the expected date of delivery.
- 6.2 For Products purchased by Distributor through the first order (i.e. article 5.3), Spineart SA accepts to exchange such Products with other Products of the same range but of different size, within the (six) 6 months following the delivery of the first order by Spineart SA.
- 6.3 Spineart SA shall regularly inform Distributor about the most recent technical characteristics of all of the Products. Furthermore, Spineart SA, on demand and expenses of Distributor, shall deliver to sale and marketing staff of Distributor the information necessary for the correct execution of their assignments without however substituting or replacing them on the Territory.

Spineart SA shall provide Distributor with marketing and technical assistance and free Product samples as it may be agreed by Parties each year.

Spineart SA shall provide Products launch Training to Distributor's personnel as set forth in the marketing program specified in Appendix 7.

- 6.4 Spineart SA shall guarantee that all the Products are in conformance with their technical characteristics and notably that they have been manufactured under directive 93/42/CEE standards. This guarantee is granted for five (5) years as from the manufacturing date, provided that such Product is used in accordance with the instructions enclosed therewith and maintained in the package provided by Spineart SA. This warranty is contingent upon proper warehousing, shipment and use of Products in accordance with the instructions enclosed therewith.

Distributor shall have to verify if Products or their packaging have not been prejudiced during their transportation or linked to their delivery to the Distributor, within ten (10) days as from Distributor's customs clearance of the Products.

The Distributor shall return without delay any Product he considers as defective, at Spineart SA expense. Such expenses shall be reimbursed to the Spineart SA in the event the relevant Product were not defective or in the event the defect were attributable to the Distributor, notably if he disregarded the Spineart SA's directives concerning the handling, stocking, packaging or use of the Products.

In case of defaults recorded by Spineart SA, which is attributable to it, the guarantee granted by Spineart SA would be strictly limited, to its own choice, to either replace any defective Product or refund an invoiced purchase price to the Distributor, via a credit note off settable against a future order from Distributor.

To activate this guarantee, the Distributor shall send any claims concerning the faulty Products, i.e. everything that does not meet the relevant Products technical specifications,

by registered mail to Spineart SA with record of receipt within fifteen (15) days as from discovery of default.

Failure by Distributor to give notice of any damage caused to Products or their packaging during their transportation, within ten (10) days as from their delivery to Distributor, as well as failure by Distributor to give notice of any defective or damaged Product or their packaging, not linked to their transportation, within fifteen (15) days as from discovery of such defect, shall be deemed a waiver, by Distributor, of Spineart SA's obligations as stated herein.

In any case, any guarantee or liability of Spineart SA is excluded if Distributor has failed to comply with its obligations under the Contract and particularly the Appendix 4, in terms of respect of quality and technical characteristics of the Products, as well as of the regulation on the Territory concerning the Product.

- 6.5 EXCEPT FOR THE LIMITED WARRANTIES PROVIDED IN ARTICLE 6.4 AND ARTICLE 7.9 OF THE CONTRACT, SPINEART SA GRANTS NO OTHER WARRANTIES OR CONDITIONS, EXPRESS OR IMPLIED, BY STATUTE, IN ANY COMMUNICATION WITH DISTRIBUTOR, SUB-DISTRIBUTORS OR CUSTOMERS, OR OTHERWISE REGARDING THE PRODUCTS, THEIR FITNESS FOR ANY PURPOSE, THEIR QUALITY, OR THEIR MERCHANTABILITY. SPINEART SA SHALL IN NO EVENT BE LIABLE FOR ANY INDIRECT, INCIDENTAL OR CONSEQUENTIAL DAMAGES, INCLUDING WITHOUT LIMITATION LOST REVENUES OR PROFITS, WHETHER A CLAIM FOR SUCH DAMAGES IS BASED UPON WARRANTY, CONTRACT, TORT, COMMON LAW, STATUTE OR OTHERWISE.

Article 7 Intellectual Property

- 7.1 The Distributor (and its Sub-distributors) acknowledges the exclusive intellectual property rights of Spineart SA attached to patents, brands, logos, corporate names, designs, models and methods of presentation and marketing of the Products on the Territory and in the rest of the world (hereafter "Intellectual Property") and shall refrain from doing anything or having something done that would lead to challenge or jeopardize the above in any manner whatsoever.
- 7.2 The Distributor (nor its Sub-distributors) will not acquire any Intellectual Property rights as a result of the signature or the execution of the Contract other than the utilization right described in article 2.3 and may not put forward or present itself to third parties as possessing any property rights.
- 7.3 The Distributor (and its Sub-distributors) agrees to use Brands whenever necessary for the purposes of the Contract. Distributor may, throughout the duration of the Contract, indicate on its letterhead and in its publicities that it is an authorized Distributor of Spineart SA Products on the Territory and may, in this capacity, use Spineart SA's corporate identification symbols in its publicities and promotional material of Products. The Distributor (and its Sub-distributors) may not under any circumstances use the Brand, corporate identification symbol or Spineart SA name for the promotion, proposals or sales of other products it may market.
- 7.4 The Distributor agrees irrevocably, for himself and on behalf of its Sub-distributors, not to undertake or have undertaken by third parties, any formality aiming at obtaining the deposit of any element of Intellectual Property for the Territory or in rest of the world.

- 7.5 The Distributor agrees to inform Spineart SA within 2 days of any unfair practices, of any nature whatsoever, on Intellectual Property on the Territory or in the rest of the world or any acts that would affect the Products and Spineart SA.
- 7.6 The Distributor agrees to provide all reasonable assistance that Spineart SA may reasonably request to preserve its rights connected to Intellectual Property matters, notably information detained by the Distributor or that it may receive through legal ways concerning the promotion, purchase, sale and resale of products illegally competing with Products in the Territory.
- 7.7 The Distributor is not authorized to take legal action against third parties for unfair practices on Intellectual Property matters or Spineart SA without the latter's prior written approval.
- 7.8 Spineart SA reserves the right to initiate any legal action before the courts or administrative bodies in the Territory and in the rest of the world necessary for the respect of Intellectual Property and rights of Spineart SA.
- 7.9 Spineart SA represents and warrants that the Intellectual Property is not infringing any third party's rights and also undertakes to indemnify and hold harmless the Distributor against all losses and damages the latter may incur as a result of a definitive court decision obtained by a third party relating to infringement of such third party's rights by the Intellectual Property.

Article 8 **Quality, archiving and traceability**

- 8.1 The Parties agree to use an archiving system of their choice for the conservation of documents and quality recordings including notably purchase orders, reception and delivery forms, batch numbers and identity of corresponding Clients for a period of twenty (20) years. Should Distributor sub-contract archiving of its information it shall remain sole responsible for the purposes of the Contract and applicable legislation.
- 8.2 The Distributor shall ensure proper traceability of the Products to the health care institutions in the Territory. The Distributor shall take necessary steps to ensure the collection of information allowing establishment of a link between batch numbers of the Products and the patients in health care institutions.
- 8.3 If necessary, the Parties agree to provide evidence as to their capacity to ensure that they are in conformance with obligations set out in paragraphs 8.1 and 8.2.
- 8.4 More generally, the Parties shall respect the standards of quality required by the technical specificities of the Products as well as the standards set forth in Appendix 4.

The requirements concerning the records of the Products sold shall enable Spineart SA to conduct an effective recall of Products in the Territory.

In the event of a recall of any of the Products required by Spineart SA, Distributor will cooperate with Spineart SA at the expense of the latter in effecting such recall, at no other costs than the reasonable costs effectively supported by Distributor relating to such recall. In all others cases of recall, costs will be supported by Distributor.

Article 9 **Force Majeure**

In the case where one of the Parties to the Contract finds it impossible, for reasons of Force Majeure, and notably in case of unavailability of usual means of transport, unavailability of raw materials, natural disasters, fire, flooding and in general all circumstances or situations which are beyond the control of the Parties, to comply in full or in part with obligations of the Contract, these obligations shall be suspended for a period equal to, but not exceeding, the length of the hindrance resulting from them.

The Party affected by an effect of Force Majeure will inform without delay the other Party and will provide all details concerning this event. The Party shall not therefore be held liable for any delay and/or impossibility in executing its obligations.

However, should the suspension foreseen by the preceding paragraph exceed a period of six (6) months, one or the other of the Parties may notify the other Party of the termination of the contract as of right.

Spineart SA may in any event appoint, as from the day the event of Force Majeure occurs, for a period equal to that of the Force Majeure event another non-exclusive distributor to ensure distribution of the Products in the Territory or for direct sale of Products in the Territory.

Article 10 **Termination**

- 10.1 In case of non fulfillment, total or partial, by either of the Parties of its obligations and notably those set out in articles 2, 4, 5, 6, 7 and 8 above, the other Party shall summon it by registered letter with record of receipt, to comply.

If the Party to whom the letter of summons is directed does not comply within 15 days following the date of receipt of such summons, and cannot justify its non-compliance by a case of Force Majeure, the other Party may, if it so wishes, terminate as of right the Contract by a termination letter sent to the faulty Party without it being necessary to send any further instructions or to appeal to any jurisdiction whatsoever.

In this regard, Distributor shall monitor the activities of Sub-distributors to ensure the respect of the Contract by the latter(s).

In case of non fulfillment, total or partial, by any Sub-distributor of the obligations set forth in the Contract and notably those set out in articles 2, 4, 5, 6, 7 and 8 above, the Distributor shall summon the faulty Sub-distributor, by registered letter with record of receipt, to comply.

If the faulty Sub-distributor to whom the letter of summons is directed does not comply within fifteen (15) days following the date of receipt of such summons, the Distributor shall terminate as of right any relationship with the faulty Sub-distributor, without any prejudice to Distributor's obligation to warrants jointly and severally Spineart SA from any damages the latter could suffer from.

10.2 However, Spineart SA may notably terminate the Contract as of right, without previous notice, if one of the following events occurs:

- Distributor does not comply with the Minimum half year turnover provided in article 5.3;
- In the event one of the statements set forth in articles 5.16 and Appendix 6 turns out to be inaccurate or wrong;
- In the event of any breach or failure by the Distributor or any Sub-distributor of any article of the Contract arising out of its negligence, fraud, bad faith or willful misconduct;
- In the event Distributor or Sub-distributors causes the loss by Spineart SA or itself of its authorizations or licenses to market in the Territory, or should it otherwise deliberately break the laws in force regarding the Products in the Territory or more generally gravely compromises the commercial image of Spineart SA.

10.3 The Contract being concluded *intuitu personae*, in case of major change in the situation of one of the Parties, such as notably the reduction of guaranties and sureties, default on payments, the opening of a collective bankruptcy procedure, amicable or judicial liquidation, cessation of activity, modification in the majority of the share capital of Distributor when, as a result of such modification, the majority shareholder is a competitor or anyone reasonably considered by Spineart SA as presenting risks concerning the products commercialization or Spineart SA's Intellectual Property protection, or the undersigned Sub-distributor, the amicable or forced transfer (to third parties – not intra-group transfers) of the entire or partial business or of an intellectual Property right concerning a Product, the devolution of assets by inheritance, and notwithstanding the execution of all contractual obligations, the Contract may be terminated by the other Party fifteen (15) days after it has notified its intention to terminate the Contract.

10.4 Except termination cases set forth in articles 3, 10.1, 10.2 and 10.3, Spineart SA shall be entitled to terminate the Contract, with a written notice, by registered letter with record of receipt, of two (2) months if sent during the second year, three (3) months if sent during the third year, and four (4) months if sent during the fourth and following years.

In such a case, Spineart SA undertakes to buy, upon first request from the Distributor, the remaining Products, in whole or in part, owned by the Distributor. Said Products shall be bought by Spineart SA for the initial purchasing price of the Products (taxes excluded) decreased of the following applicable percentage:

- Sterile implants: 20% per annum, as of the second year of storage by the Distributor or any third party;
- Instruments: 33% per annum of storage by the Distributor or any third party;
- Non sterile implants in closed pouch: 20% per annum, as of the second year of storage by the Distributor or any third party;
- Non sterile implants in its original status in opened pouch or without pouch, and implants of a previous generation (i.e. replaced by new generation products) and no longer manufactured by Spineart SA for more than 3 months: 100%.

For the implementation of the above-mentioned buyback of the Products by Spineart SA, the Distributor shall provide to Spineart SA a complete inventory of Products in Distributor's possession.

10.5 As from the notification of a termination letter based on, but not limited to, articles 3, 10.1 to 10.3 herein above, Distributor's exclusive right to distribute the Products in the Territory shall become non-exclusive and Spineart SA shall be entitled to appoint one or more non-exclusive distributors of the Products in the Territory to take effect at any time as from the effective date of delivery of such notice. For the avoidance of doubt, the present paragraph shall apply to any notice period when applicable, except when the notification of a termination letter is based on paragraph 1 of Article 3 herein above, where in such case Distributor's exclusive right to distribute the Products in the Territory shall become non-exclusive as from the expiry of the seventy-five (75) days notice period provided by the above mentioned article.

10.6 As from the notification of a termination letter based on an event of default (i.e. pursuant to articles 10.1 to 10.3 herein above), the Distributor shall be obliged to pay Spineart SA the balance of all of its unpaid bills on day of their due date.

In such a case, the Distributor (and its Sub-distributors) shall cease, as from notification of said termination, using the brands, corporate identity symbol and name of Spineart SA immediately and shall (pursuant to the instructions which will be provided to Distributor) return to Spineart SA all and any Product and return all documents, information or material remitted with respect to the implementation of the Contract. Distributor warrants to Spineart SA that any Sub-distributor shall cease, as from notification of said termination, using the brands, corporate identity symbol and name of Spineart SA in the same conditions.

The previous paragraphs shall take effect at the end of the notice period, when applicable, in any case where a termination letter is not based on an event of default.

10.7 The termination of the Contract, for any case whatsoever, shall imply, automatically and without further notice or notification, the termination of any relationships between the Distributor and its Sub-distributors in respect of the Contract. In any case, Sub-distributors shall not be entitled to bring claims against Spineart SA.

Distributor shall not be entitled to, and waives its rights to, any termination compensation or consequential damages or indemnity even for potential loss of goodwill, loss of profits, for potential costs of re-establishment or of replacement of its business nor any other expenses or rights relating to its business developed or established on the bases of this Contract or to its termination. Distributor recognizes that the prices of the Products allow obtaining a margin on resale prices to its clients, which cover its expenditures.

Distributor irrevocably undertakes to guaranty Spineart SA from any direct or indirect damaging consequences supported by the latter in respect of any claim brought by any Sub-distributor, agent or employee, and Spineart SA shall be entitled to claim to Distributor any compensation of such consequences.

Distributor agrees to indemnify and hold Spineart SA harmless from any consequences, losses, damages, amounts, costs and expenses incurred by Spineart SA as a result of a breach by the Distributor of articles 2, 5, 7, 8 or 11.

Any of the Parties agrees to indemnify and hold the other Party harmless from any consequences, losses, damages, amounts, costs and expenses suffered by the latter as a result of a breach of this Contract by a Party arising out of its negligence, fraud, bad faith or willful misconduct.

Article 11 Transfer or cession

The Contract is concluded "intuitu personae" and the Distributor may not transfer or hand over all or part of the latter nor its rights or contractual obligations without the prior written consent of Spineart SA.

In the case where Spineart SA is bought over or party to a merger agreement, Spineart SA will pursue the Contract until expiry of its term. In the aforementioned case, the Distributor will also pursue the Contract until the expiry of its term, unless the party acquiring or merging with Spineart SA is causing the Distributor or Sub-distributor a breach of a non-compete obligation to which it is subject to vis-à-vis third parties.

In the case where Spineart SA transfers or hands over Intellectual Property rights of one or more of the Products or its entire or partial part of its assets to a third party during the period of validity of the Contract, Spineart SA shall have the possibility of denouncing the Contract at any time subject to a notice period of six (6) months according to the provisions of article 10.

Article 12 Miscellaneous provisions

12.1 Non disclosure

Each Party hereto shall strictly maintain and shall cause its officers, directors, employees, agents and Sub-distributors to so maintain, the confidentiality of any trade secrets, know-how, customer lists, financial information or other proprietary information of the other Party which is not a matter of public knowledge at the time of its disclosure to such Party (together, the "Confidential Information") both during the term of the Contract and for five (5) years thereafter, until such time as that Confidential Information becomes a matter of public knowledge through no act or omission of such Party or its officers, directors, employees, agents and Sub-distributors. For purposes hereof, Confidential Information shall not include information disclosed by one Party to the other Party which such other Party can establish (a) was known by the other Party or any of its divisions, subsidiaries or affiliates prior to the date thereof, except in the case of information previously supplied to Distributor by Spineart SA; (b) was received by the other Party from a third party having the lawful right to disclose such information; (c) was developed by the other Party without the benefit of the Information; or (d) entered the public domain through no fault of the other Party. Neither Party shall use or permit to be used

the Confidential Information of the other Party for any purpose other than for the carrying out the terms of the Contract without the disclosing Party's prior written approval.

12.2 Notifications

Any notifications, inquiries, requests or other communication required by or that would be made in virtue of the Contract, should be done by registered mail with record of receipt or equivalent notice, to the addresses of each Party as indicated on heading of the present document, or other address that either Party may have notified in writing to the other Party. All of these notifications, inquiries, requests and communications shall be considered received upon first presentation.

12.3 The Contract cancels and supersedes any former exchange of documents or former agreements between the Parties relating to all or part of the object of the Contract.

12.4 Amendments – renunciation

None of the provisions of the Contract may be amended, removed or modified in any way whatsoever without the prior written consent of the Parties duly-represented.

Any term or condition of the Contract may be renounced at any time by the Party that benefits from same; said renunciation being formalized in writing and signed by said Party. A renunciation arriving on one occasion shall not be considered as constituting a renunciation of a violation or any violations arising on a later occasion.


12.5 The nullity or the non-enforceable character of a provision of the Contract shall not affect the validity or the enforceable character of the other provisions of the Contract, which remain in force in their entirety. The Parties shall negotiate in good faith the void or non-enforceable stipulations so that said stipulations may become valid and enforceable.


12.6 Applicable Law and Court jurisdiction


The Contract is governed in its entirety by Swiss law.

Any disputes arising from the interpretation of the Contract and that cannot be resolved amicably between the Parties shall be submitted to the Competent Tribunal of the head office of Spineart SA in Switzerland.
