Article 1 Subject

The subject of the contract shall be the supply, of the following supplies:

- Backhoe (1 piece) with the following accessories:
 - Escavare 300 mm Cup (1 piece);
 - Trapeze Cup for ditches (1 piece);
 - Quick bucket change device (1 piece);
 - Bolts kit for quick grip cups (1 piece);
 - Air conditioning (1 piece);
- Snow blade working width 2800 mm with profile in "V", hydraulic tilt, equalization system and support wheels (1 piece).

The place of acceptance of the supplies shall be Carahasani, Carahasani village in Ștefan Vodă district of the Republic of Moldova, within a maximum of 60 days (according to the information in the contract) from the signing of the contract by both parties.

The implementation period of tasks shall run from receiving the start order to 60 days

1.2 The contractor shall comply strictly with the terms of the special conditions and the technical annex.

1.3 The supplies which form the -Backhoe and accessories must be accompanied by the spare parts described by the contractor in its tender and by the accessories and other items necessary for using the goods over a period of 2 years, as specified in the instructions to tender.

Article 2 Origin

The rules of origin of the goods are defined in Article 10 of the special conditions.

A certificate of origin for the goods must be provided by the contractor at the latest when it requests provisional acceptance of the goods. Failure to comply with this condition may result in the termination of the contract and/or suspension of payment.

Article 3 Price

3.1 The price is 73.450 euro, excluding VAT

3.2 Payments shall be made in accordance with the general and/or special conditions (Articles 26 to 28).

Article 4 Order of precedence of contract documents

The contract is made up of the following documents, in order of precedence:

- the contract agreement;
- the special conditions
- the general conditions (Annex I);
- the technical specifications (Annex II [including clarifications before the deadline for submission of tenders and minutes from the information meeting/site visit]);
- the technical offer (Annex III)
- the budget breakdown (Annex IV);
- [specified forms and other relevant documents (Annex V);

The various documents making up the contract shall be deemed to be mutually explanatory; in cases of ambiguity or divergence, they shall prevail in the order in which they appear above.
