CONSORTIUM AGREEMENT BETWEEN THE COMPANIES "PAYNET SERVICES" SRL

AND KENTKART EGE ELEKTRONIK SAN VE TIC A.S.

THIS Consortium Agreement (hereinafter the "Agreement") is subscribed on 25th of April, 2019, by and among the following companies: "PAYNET SERVICES" S.R.L., a company under the laws of Republic of Moldova, with its offices located at blv. Decebal 6, Chisinau, Republic of Moldova, fiscal code (IDNO) 1013600036596, (hereinafter "PAYNET"), represented in this act by Greadcenco Călin (with moldavian ID number 0970108182732) in its condition of Legal Representative (Administrator (CEO)); and KENTKART EGE ELEKTRONIK SAN VE TIC A.S., a Corporation incorporated under the laws of Turkey, with its registered domicile at Gümüssuyu Mah, Muhtar Kamil Sok., No 3/4 34437 Taksim, Beyoglu, Istanbul, Turkey (hereinafter "KENTKART"), represented in this act by Muhammet Emin Demir (with Turkish ID Number 22555806890) in its condition of Legal Representative; the companies aforementioned shall be known collectively as the "Parties", or individually as the "Party".

Therefore, the Parties hereby agree to the following.

1. Subject matter of the Agreement

- This Agreement records the mutual understanding between the Parties and provides a framework for future discussions on the implementation and accomplishment of certain activities related to the execution of the project related to the Invitation to Tender N° 221-1 (About the operator of electronic systems in the city of Lutsk) (the "Project"), invitation issued in Lutsk City, Ukraine, on 03 April 2019.
- 1.2 The Parties agree in addition that the purpose of this Agreement is to specify the commitments and preliminary principles reached during the negotiations between them under a possible provision of one or (more) definitive agreements (hereinafter the "Final Agreement") in connection to the Project in Lutsk City.

2. Preliminary Commitments of the Parties

- 2.1 In connection with paragraph 1, the Parties agree the following preliminary commitments:
 - (a) The Parties shall develop jointly a synergistic commercial offer to execute in due form and based on the jointly experience that all parties have an Electronic Collection System with No Contact-Smartcard for the Public Transport of the City of Lutsk.
 - (b) Given the above, the Parties shall cooperate to define an action plan aimed to develop the terms of such bid that shall be submitted to the competent authority.
 - (c) The Parties agree to perform the following activities described in Annex 1 of this Agreement (below).
 - (d) The Parties agree to work jointly and in solidarity for the Project, so neither Party is allowed to present independent bids or to present bids using a channel and terms different from the provisions of the Agreement.
 - (e) The Parties of common agreement shall designate the PAYNET company as the principal of the consortium, in this sense, the PAYNET company shall represent the consortium and shall sign all the respective documentation in case the consortium awarded the Project.

3. Confidentiality

Regarding to the scope of this Agreement and to the negotiations contemplated herein, the Parties 3.1 have exchanged and shall exchange also, several types of information (financial, economic, commercial, business, among others) that is not available to public (hereinafter collectively as the "Confidential Information"). The Confidential Information shall include, but it is not limited to, all the information and documents provided by the other Party, including technical data, client data base, financial and business information, correspondence, oral and written presentations, memorandums, reports, files, or any other information. The Confidential Information shall also include all tangible information that contains such Confidential Information, including without limitation, written or printed documents and disks or computer tapes, either machine or readable to the user. The Confidential Information shall not include information that (a) was rightfully in possession of or was known by the recipient Party without any obligation of confidentiality before receiving it from the disclosing Party; it is, or it turns subsequently, legal and available to the public without breaching this Agreement; (b) it is legally obtained by the recipient Party from a different source than the discloser Party without any obligation of confidentiality; (d) it is developed by or for the recipient Party without the use of the Confidential Information and such independent development can be demonstrated with documentary evidence; or (e) it is disclosed by the recipient Party under valid order issued by an agency of the court or governmental, as long as the recipient Party provides prior written notification to the discloser Party of such obligation and the opportunity to oppose to said disclosing.

4. Term

- 4.1 This Agreement shall enter into force once it is duly signed by all the Parties. It shall remain in force during the term of execution of the Project provided that it previously mediates its adjudication.
- 4.2 In the case that the Project was not awarded to the Parties, the present Agreement shall be terminated immediately whether it is known the decision by the respective authorities except in the case of any other written agreement between the Parties or unless the Parties agree to extend the term of this Agreement.

5. Nature of the Agreement

- The Parties have signed this Agreement only for the purpose of evidencing their mutual understanding with respect their intention to proceed over the bases herein described. Therefore, and according to the following provisions, this Agreement is a mandatory expression of the attempt of the Parties and constitutes an Agreement legally binding to comply with the established about joint participation in the presentation of the bid.
- None of the Parties shall have any responsibility whatsoever in the event that the Project is not adjudicated to the Parties that subscribe the following Consortium Agreement.

TERMS OF AGREEMENT
