Ad 5.2: Terms of payment

The Consultant's remuneration shall be paid against presentation of an invoice, indicating the BMZ-No. (KfW-Reference No., see § 1.1. Definitions "Project"), as follows:

497,631.00 EUR 20% advance payment (upon presentation of the advance payment guarantee). Due within 30 days upon entry into force of this contract against presentation of a corresponding invoice.

1,741,708.50 EUR Nine (9) consecutive half-yearly instalments (70%), each payable within 30 days upon presentation of a corresponding invoice and upon approval of the respective Semi-Annual Reports:

After 6 months: 193,523.17 EUR

After 12 months: 193,523.17 EUR

After 18 months: 193,523.17 EUR

After 24 months: 193,523.17 EUR

After 30 months: 193,523.17 EUR

248,815.50 EUR as the final payment (10%), after acceptance of the final report by PEA and KfW, payable within 30 days upon presentation of a corresponding invoice.

Ad 5.3: Method of payment

The Consultant's invoices are to be made out to the Employer "c/o KfW". KfW shall receive the original invoice. A copy of the invoice shall be sent to the Employer directly. The original of the final invoice is to be sent to the Employer, KfW receives a copy.

Ad 5.4.1: Price adjustment

Base index foreign currency costs: Index of the living costs in Germany as published by the German Federal Statistics Office (Statistisches Bundesamt).

Base index local currency costs: not applicable

Ad 5.5: Payment deadline

Agreed compensation for overdue payments pursuant to Paragraph 5.5 [Payment Deadline]: 9 per cent per year over the base rate, in relation to the outstanding amount.

The applicable currency for the Contract shall be Euro (EUR).

Ad Article 6: Liability

The Consultant's liability shall terminate on the date of the end of the 12 months defects liability period (DLP).

Ad Article 7: Insurance

The Consultant shall take out a professional personal liability insurance (for employees) covering a damage of up to 5 mio EUR (double aggregated per year) and a pecuniary liability insurance (for buildings and equipment) covering the damage of 2,5 mio EUR (double aggregated per year).

Motor vehicles belonging to the Consultant will be insured as per national regulation of the Kyrgyz Republic.

Ad Article 8: Disputes and Arbitration Procedure

Ad 8.2: Mediation

The mediator shall be appointed by the International Chamber of Commerce (www.iccwbo.org) and the appointment shall be binding for the parties.

The costs of the mediation and of the mediator's services shall be shared equally between the parties.
