Whereas the contracting authority would like the contractor to carry out the following works:


and has accepted a tender by the contractor for the execution and completion of such works and the remedying of any defects therein.

It is hereby agreed as follows:

- (1) In this contract, words and expressions shall have the meanings assigned to them in the contractual conditions set out below.
- (2) The following documents shall be deemed to form and be read and construed as part of this contract, in the following order of precedence:

- (a) the contract,
- (b) the special conditions,
- (c) the general conditions,
- (d) the technical and/or performance specifications,
- (e) the design documentation (drawings),
- (f) the breakdown of lump-sum price,
- (g) the tender,
- (h) any other documents forming part of the contract.

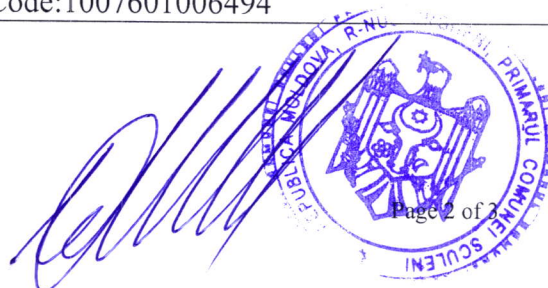
The various documents making up the contract shall be deemed to be mutually explanatory; in cases of ambiguity or divergence, they shall prevail in the order in which they appear above. Addenda shall have the order of precedence of the document they are amending.

- (3) In consideration of the payments to be made by the contracting authority to the contractor as hereinafter mentioned, the contractor undertakes to execute and complete the works and remedy defects therein in full compliance with the provisions of the contract.
- (4) The contracting authority hereby agrees to pay the contractor in consideration of the execution and completion of the works and remedying of defects therein the amount of:
 - Contract price (excluding VAT/other taxes) [EUR] 90914,10
 - VAT and other taxes [EUR] 0
 - Contract price [EUR] ninety thousand nine hundred and fourteen Euros and 1 euro cent
 or such other sum as may become payable under the provisions of the contract at the times and in the manner prescribed by the contract. VAT and other taxes shall not be paid on the funds originating from EU funds.
- (5) The parties agree to the set of rights and obligations described in the attached contractual documents.
- (6) Payments will be made in 3 tranches, with the execution of the works and the presentation of the provisional acceptance documents of the executed works. The last payment will be made after the final reception of the works.
- (7) To confirm the aforementioned, the parties signed this Contract, on the date and year indicated, being valid until 31.12.2023.
