Conclusion

Visitor chair ISO BLACK (SENC) C-11 complies with the standard EN 16139:2013 including corrigendum EN 16139:2013/AC:2013 (Furniture – Strength, durability and safety – Requirements for non-domestic seating) level of test severity L1 requirements.

Test object

Visitor chair ISO BLACK (SENC) C-11 with soft seat and backrest. Legs and supports of backrest are bent of (30x15) mm tube in oval shape, stretchers of ø 18 mm steel tube. Legs and stretchers are welded, welding seams are visible on both sides of the joints. Seat and backrest are made of 6 mm thick plywood, foam and upholstery fabric. Height of soft part of seat is 30 mm, backrest 15 mm. Ends of legs are covered with plastic covers. Bottom of seat and rear part of backrest have a plastic shields.

External dimensions of chair are: width between the legs in transversal direction 555 mm, length of legs in longitudinal direction 480 mm, external depth 600 mm, height 800 mm. Width of seat is 470 mm, depth 420 mm, height in the median plane is 475 mm. Dimensions are for general information only 1557.
