#### **(1) Subject**

- 1.1 The subject of this contract is ICT SERVICES done in Chisinau with identification number 3/ BSB 831/ 2021(‘the services’).
- 1.2 The contractor shall execute the tasks assigned to him in accordance with the terms of reference annexed to the contract (Annexe II)

#### **(2) Contract value**

This Contract, established in Euro and national currency, is a global price contract. The total contract value is 25 800 Euro (Twenty-five thousand eight hundred Euro) without VAT. **Payments will be made in Moldovan Lei**, in accordance to the applicable law, at the official

exchange rate of the National Bank of Moldova at the transaction date, no later than 30 days following submission by the Contractor of the Fiscal bill.

### (3) Order of precedence of contract documents

- the terms of reference (Annex II)
- the organisation and methodology (Annex III);
- Key experts (Annex IV);

**These above listed documents make up the contract. They shall be deemed to be mutually explanatory. In cases of ambiguity or divergence, they shall prevail in the order in which they appear above. Addenda shall have the order of precedence of the document they are amending.**
