## Oracle Certification Program Policies

### Admission Policy

We ask that you arrive at the test center 15 minutes before your scheduled appointment time. This will give you adequate time to complete the necessary sign-in procedures. If you arrive more than 15 minutes late for an exam and are refused admission, payments are due for the exam and delivery fees. Prior to entering the testing room, candidates are identified and processed for admission by the Test Administrator.

### Identification (ID) Requirements

- The first and last name that the candidate uses to register must match exactly the first and last name on both of the IDs that are presented on test day.
- All IDs required must be issued by the country in which the candidate is testing. If the candidate does not have a qualifying primary ID issued from the country they are testing in, a passport from their country of citizenship is required, along with a secondary ID.
- Candidate is required to present two forms of original (no photo copies), valid (unexpired) IDs; one form as a primary ID (government issued with name, photo, and signature) and one form as a secondary ID (with name and signature).

### Exceptions:

- Expired forms of ID are not acceptable; unless accompanied by valid renewal papers.
- Any government issued ID missing a visible signature or that has an embedded signature, can be supplemented with an original (no photo copies), valid (unexpired) ID that has at least a matching name and signature. This would be in addition to any exam sponsor (client) secondary ID requirement.
- Any candidate exceptions to the ID policy must be pre-approved by the Pearson VUE customer service center at least three business days before the scheduled exam appointment.\*If you have any questions about the ID you are required to bring with you to the testing center for

admittance for your exam, please contact Pearson VUE customer service at [www.pearsonvue.com/contact](http://www.pearsonvue.com/contact).

Prior to taking the exam, you will be required to accept the terms and conditions of the Oracle Certification Candidate Agreement. You will view the agreement on screen before the exam starts. You can also view this agreement prior to arriving at the testing center by clicking the following link: [Oracle Certification Candidate Agreement](#). If you choose not to accept the agreement at the test center, your exam will be immediately canceled and you will forfeit your exam fee. Please review this agreement before arriving at the test center. You will not be allowed to take any personal items with you into the testing room. This includes all bags or purses, books, notes, personal computers or devices, cell phones, pagers, watches and wallets.

### Reschedule Policy

If you wish to reschedule your exam, you must contact Pearson VUE one business day prior to your exam appointment. Rescheduling an exam less than 24 hours before scheduled exam is subject to a same-day forfeit exam fee. Exam fees are due for no-shows.

### Cancellation Policy

If you wish to cancel your exam, you must contact Pearson VUE one business day prior to your exam appointment. Canceling an exam less than 24 hours before scheduled exam is subject to a same-day forfeit exam fee. Exam fees are due for no-shows.
