



1.3 Intended use

The HistoCore PEARL is designed to enable tissue processing, performing all steps from fixation to wax infiltration. It is normally processed in sequential mode, which means that the instrument is strictly using one bottle after the other.

The HistoCore PEARL is a tissue processor for the following laboratory applications:

- Fixation
- Dehydration
- Infiltration with intermedium
- Paraffin infiltration

of histological tissue specimens.

The HistoCore PEARL must be operated exclusively with the reagents listed in the section of Compatible reagents (\rightarrow P. 20 – 3.4 Compatible reagents).

Caution

Any other use of the instrument is considered Off Label use.

Failure to observe these instructions may result in an accident, personal injury, damage to the instrument, accessories or specimens.

Proper and intended use includes compliance with all inspection and maintenance instructions, along with the observance of all instructions in the Instructions for Use.

1.4 Qualification of personnel

- The HistoCore PEARL must be operated by trained laboratory personnel only.
- All laboratory personnel designated to operate this instrument must read these Instructions for Use carefully and must be familiar with all technical features of the instrument before attempting to operate it.

2. Safety

2.1 Safety notes

The Instructions for Use includes important information related to the operating safety and maintenance of the instrument.

The Instructions for Use is an important part of the product, and must be read carefully prior to startup and use and must always be kept near the instrument.

This instrument has been built and tested in accordance with the safety requirements for electrical equipment for measurement, control, and laboratory use.

To maintain this condition and ensure safe operation, the user must observe all notes and warnings contained in the Instructions for Use.

- The safety and caution notes in this chapter must be observed at all times.
- Be sure to read these notes even if you are already familiar with the operation and use of other Leica Biosystems products.
- The protective devices located on the instrument and the accessories must not be removed or modified. Only qualified service personnel authorized by Leica Biosystems may repair the instrument and access its internal components.
- The instrument has been designed and constructed with the latest state-of-the-art technology and according to recognized standards and regulations with regard to safety technology. Operating or handling the instrument incorrectly can place the user or other personnel at risk of injury or can cause damage to the instrument or other property. The instrument must be used only as intended and only if all of its safety features are in proper working condition. Malfunctions which could impede safety must be remedied immediately.
- Only original spare parts and permitted original accessories can be used.

2.2 Warnings

The safety devices installed in this instrument by the manufacturer only constitute the basis for accident prevention. Operating the instrument safely is, above all, the responsibility of the owner, as well as the designated personnel who operate, service or repair the instrument.

To ensure trouble-free operation of the instrument, be sure to comply with the following instructions and warnings.

2.2.1 Markings on the instrument itself

\triangle

Caution

Markings on the instrument showing the warning triangle indicate that the correct operating instructions (as defined in the Instructions for Use) must be followed when operating or replacing the item marked. Failure to observe to these instructions may result in an accident, personal injury, damage to the instrument, accessories or specimens.



A Caution

Some instrument surfaces become hot during operation. They are marked with this warning label. Touching these surfaces may cause burns.

2.2.2 Transport and Installation

🔨 Ca

- Once unpacked, the instrument must be transported only in an upright position.
- Follow the unpacking instructions carefully to avoid damage to the instrument!
- Prior to every transport in which it is possible for the instrument to be shaken, tilted, or lifted, it
 must be cleaned including the tubing, paraffin baths and reagent bottles otherwise the interior
 of the instrument can be severely damaged.
- Plug the instrument only into a grounded power socket. Make sure an obligatory use of a CB (Circuit breaker).
- Severe damage may occur if the instrument is connected to a power supply voltage other than that to which it shows on the nameplate.
- The installation location must be well-ventilated; there should be no ignition sources there of any kind. The chemicals to be used in the HistoCore PEARL are both flammable and noxious.
- Do not operate the instrument in rooms with explosion hazard.
- Extreme temperature fluctuations between storage facility and setup site as well as high humidity may cause condensation to form. If this is the case, wait at least two hours before switching on the instrument. Failure to comply with this may cause damage to the instrument.

2.2.3 Operating the instrument

Caution

- The instrument can only be operated by trained laboratory personnel. It must only be operated for the purpose of its designated use and according to the instructions contained in the Instructions for Use.
- Failure to observe the instructions specified by the manufacturer may result in damage to the protection provided by the instrument.
- Pre-installed Leica Biosystems programs are validated based on Leica Biosystems consumables and reagents.
- Before using the instrument, run the Bottle Check function to check the connections of the reagent bottles and paraffin baths. Make sure that they are properly connected. Prevent any leaks or blockages.
- Before opening the retort when a program is in progress, always press the pause button so that the retort is ventilated or vented.
- After refilling/replacing reagent bottles, make sure the reagent bottles caps are closed tightly.
- The reagent bottles must be properly pushed home into the connection manifolds at the rear inner wall of the reagent module.
- Failure to plug the reagent bottles into the manifold correctly will interrupt the program process and may also result in spilling of reagents.
- Fixing solutions that contain mercury salts, acetic acid, or picric acid can cause corrosion on metal components.
- When there is a potential exposure to the infective material and/or toxic vapor, please wear chemical protective clothing, protective goggles, respirator, rubber gloves and all other necessary personal protective equipment.

Caution

In exceptional situations (e.g. accidental reagent spills), it may be necessary to wear a respirator. This depends on the specific local ambient temperature, room volume, additional load, ventilation rate etc. In case of doubt, the laboratory owner/operator must carry out a local measurement to prove that applicable maximum workplace concentrations are not exceeded. Measurements performed of maximum workplace concentrations that occur at an air change rate of 8 times per hour and a room temperature of 40 °C, room volume of 18 m³ and reagent temperature of 45 °C have shown that limit values are exceeded for short periods during the step when specimens are loaded in formalin. At lower ambient temperatures and/or larger room volumes in the laboratory or higher ventilation rates, the workplace concentration will be less. The exact concentration values can only be measured locally. The limits were complied with in all operating states.

Caution

The electromagnetic environment should be evaluated prior to operation of the instrument. Do not use this instrument in close proximity to sources of strong electromagnetic radiation (e.g. unshielded intentional RF sources), as these can interfere with the proper operation.

2.2.4 Handling reagents

Caution

- To prevent damage to the instrument, use only the reagents listed in Chapter 3.4 (→ P. 20 3.4 Compatible reagents)!
- Do not use acetone, benzene, chloroform and trichlorethane on HistoCore PEARL.
- When disposing of spent reagents, observe the applicable local regulations and the waste disposal regulations of the company/institution in which the instrument is being operated.
- Do not clean reagent bottles in a dishwasher; the reagent bottles are NOT dishwasher-proof.

A Caution

- Reagents used for tissue processing can be both toxic and/or flammable. Take care when handling reagents! Always wear chemical protective clothing, protective goggles, respirator, rubber gloves and all other necessary personal protective equipment.
- Keep the instrument away from fire and heat.



A Caution

Use caution when handling paraffin or removing the specimens/baskets from the retort – molten paraffin is hot and may cause burns. Also, avoid personal contact with paraffin baths and retort walls – they can be hot as well.



Caution

- When handling fixation, dehydration or clearing reagents(e.g Formalin, alcohol, xylene, etc.), wear Personal Protective Equipment (lab coat, protective goggles, respirator, rubber gloves, etc.).
- When handling infiltration reagents(e.g paraffin, etc.), wear Personal Protective Equipment (lab coat, protective goggles, respirator, safety gloves, etc.).

- For toxic reagents, such as fixation reagents (e.g Formalin), clearing reagents (e.g xylene), store them in a cool, ventilated warehouse / safe cabinet, and keep them away from fire and heat. When handling the toxic reagents, wear personal protective equipment (lab coat, protective goggles, respirator, rubber gloves, etc.).
- For flammable reagents, such as dehydration reagent (e.g absolute alcohol, diluted alcohol, etc.), infiltration reagents (e.g paraffin), store them in a cool, ventilated warehouse / safe cabinet, and keep them away from fire and heat. When handling the flammable reagents, wear personal protective equipment (lab coat, protective goggles, respirator, rubber gloves/safety gloves, etc.).

2.2.5 Cleaning and maintenance

Caution

- Do not clean the instrument with solvents containing acetone or xylene. No liquid may be spilled into the internal components of the instrument neither during operation nor during cleaning.
- When using cleaners, please comply with the safety instructions of the manufacturer and the laboratory safety regulations.
- · Check the condensate bottle at least once a week and empty it.
- If the instrument is not to be used for a long time, drain out the reagent and paraffin. Use deionized water to clean the formalin bottle and water bottle, and dry; use alcohol to clean the alcohol bottle, xylene bottle and paraffin baths, and dry; use alcohol to wipe clean the instrument exterior.

2.3 Safety features on the instrument

The HistoCore PEARL tissue processor is equipped with safety functions and with sophisticated software control mechanisms. These ensure that the specimens remain undamaged in the event of a power failure or other malfunction during the program and that the program is completed successfully.

2.3.1 **Overpressure protection**

- When the power is switched off, the pressure air pump and valves default to a safe condition (retort vented, no pressure generation).
- In addition, there is a relief valve that vents all excess air pump output to atmosphere.

2.3.2 **Overcurrent protection**

Ref 4

Overcurrent conditions are protected against by the main fuse overcurrent protection.

2.3.3 **Overheating protection**


The heat limiter protects the instrument against the abnormally high temperature.



3.2 Main features of the instrument

- The HistoCore PEARL is equipped with an LCD touch screen. Multilingual user interface and graphic display of the program flow (dashboard) are for clarifying all menu steps. Ref 2
- The HistoCore PEARL can be operated using customized or pre-installed, validated tissue processing programs. There are 3 pre-installed, non-editable programs available, including 1 Cleaning program, 1 Overnight and 1 Biopsy. Ref 5
- 10 processing programs are freely configurable with up to 14 steps (temperature; time; reagent; Ref 7 pressure/vacuum options).
- Reagent Management System (RMS) enables the users to monitor the usage of reagents per number Ref 3 of cassettes, cycles or days.
 - The quick start system enables the users to start each program immediately from the Favorite program panel (max. 5 programs).
 - The number of cassettes, number of processing cycles, days since the last change and the reagents to be replaced can be displayed according to the customized settings of the RMS.
 - Three paraffin baths are used for the tissue infiltration, each with a max. capacity of 3.5 L of liquid paraffin. The paraffin baths can be easily removed for cleaning simply by pulling them out. The paraffin drip tray is used to collect any spilled paraffin.
 - Harmful reagent vapors are continuously suctioned back from the retort into the instrument and
- filtered even after the retort is opened, e.g. to reload cassettes or baskets. The instrument uses an Ref 1 active carbon filter. In addition, it is recommended to connect the instrument to an external vacuum extractor via a separate port on the rear of the instrument.

- The retort is capable of holding up to 200 standard cassettes depending on whether it is operated with one or two baskets.
- RemoteCare Internet connection between the instrument and the Service Support Team enables Ref 17 optimized service through monitoring of the instrument and its functions.
- The user can transfer all processing programs and logs via USB. Ref 8
- Access to the instrument can be limited via a multilevel password protection system.
- The user can utilize the Bottle Check function to ensure connecting status of reagent bottles.
- In the event of a power failure, the alarm system is triggered off. The HistoCore PEARL will provide recovery measures after interruption.
- In the event of an error, an alarm is sound immediately. The system will retry first to recover, if this is unsuccessful the instrument will then fill the retort with a safe reagent to ensure the safety of specimens if no operation is taken on the display in 15 minutes.
- Three alarm modes: instrument alarm, local alarm and remote alarm, enable the customers to be alerted whenever necessary.

Note

Fixatives containing mercuric salts, acetic or picric acid will corrode metallic components in the instrument and shorten instrument life.

If you choose to work with such fixatives, change the processing water at least every 600 cassettes or 3 cycles, to minimize the damage.

In addition, we recommend regular preventive maintenance by Leica Biosystems Technical Service.



Caution

Reagents other than these listed here may damage components of the instrument. Do not use acetone, benzene chloroform and trichlorethane in the instrument.

3.5 Recommended reagent handling

- The recommended temperature for Formalin is 37 °C.
- The recommended temperature for processing water is ambient temperature.
- The recommended temperature for processing alcohol and xylene is 45 °C.
- The temperature for cleaning xylene in the cleaning cycle is 67 °C.
- The temperature for cleaning alcohol in the cleaning cycle is 62 °C.
- The use of formalin reagents containing zinc chloride can cause corrosion of the instrument.

4. Initial Operation

4.1 Installation site requirements

- The instrument requires an installation area of approximately 700 x 800 mm.
- The substrate must have a sufficient load capacity and rigidity with respect to the weight of the instrument.
- The instrument is designed for indoor use only.
- The instrument must be installed in a place that ensures an easy disconnection from the power supply. The power cable must be in a place that can be easily reached.
- No extension cable can be connected.
- The instrument MUST be connected to a grounded power socket.
- Use only one of the provided power cables that is intended for the local power supply.
- Avoid vibrations, direct sunlight and heavy variation in temperature.

Caution

<u>/!\</u>

The chemicals used in the HistoCore PEARL are easily inflammable and hazardous to health. Therefore the installation location must be well ventilated, and must contain no open flames. The room in which the instrument is located must not be used as a permanent station for people. Otherwise the room must be equipped with an exhaust device.

The installation location must be protected against electrostatic discharge.

Do not operate the instrument in rooms with explosion hazard.

To ensure proper function of the instrument, it must be set up while maintaining a minimum distance of 10 cm from walls and furniture.

4.3 Unpacking and installation

\triangle

Caution

The packaging has two indicators (\rightarrow "Fig. 4-10") (\rightarrow "Fig. 4-11") that indicate improper transport. When the instrument is delivered, check this first. If one of the indicators is triggered, the package was not handled as prescribed. In this case, please mark the shipping documents accordingly and check the shipment for damage.



Caution

At least TWO persons are required when unpacking the instrument.

If the instrument is moved over stairs, please call your local Leica Biosystems Technical Service, who can safely transport it with appropriate equipment.



Cautio

DO NOT use the handles on the rear panel to carry, as they are not designed to bear the weight, but only for rolling the instrument.

Unpacking the instrument

- ③ Before unpacking the instrument, read the unpacking instructions carefully. They are attached to the outside of the transport packaging.
- ③ Sufficient surface area is required for unpacking the instrument. The distance to the nearest wall must be at least 1 m on the side and rear. On the front, the distance must be at least 3 m, as the HistoCore PEARL is rolled from the pallet in this direction.
- ③ Bring the instrument package as close as possible to the final installation location.

- 1. Remove the straps (\rightarrow "Fig. 4-1"), then the cover (\rightarrow "Fig. 4-2").
- 2. Unfasten 3 plastic locks (\rightarrow "Fig. 4-3") on the front side and remove the carton wall (\rightarrow "Fig. 4-4").
- 3. Remove the compression strap (\rightarrow "Fig. 4-5").
- 4. Remove the molded foam (\rightarrow "Fig. 4-6") on the top of the instrument.
- 5. Unfasten 4 screws (\rightarrow "Fig. 4-7") and remove the wooden transport anchor (\rightarrow "Fig. 4-8").
- 6. Carefully remove the plastic dust cover (\rightarrow "Fig. 4-9") from the instrument.
- 7. Pull out the two rails (\rightarrow "Fig. 5-10") from beneath the instrument by pulling them towards you.
- 8. Hook these rails into the groove on the left and right (\rightarrow "Fig. 5-11") of the pallet so that they are flush with the wooden board (\rightarrow "Fig. 5-12") that holds the instrument.



9. Push the instrument from the pallet.

Caution

The instrument casters move very easily. The empty weight of the HistoCore PEARL is 140 kg! Therefore, it is mandatory to have at least TWO persons hold the instrument when it is rolled off the pallet via the ramp.

When moving the instrument down from the pallet, one person should support it by the outer top corners using both hands; the other person holds the rear of the instrument securely by both handles (→ "Fig. 6"). Do not support the instrument on the fragile glossy plexiglass area (→ "Fig. 6-1").





During unpacking, make sure to keep the accessory box in the upright direction as indicated by the transportation symbol on the packaging box. Otherwise, the accessories could fall out and become damaged.

Note

The packaging must be retained for the duration of the warranty period. To return the instrument, follow the instructions above in reverse order.

4.4 Basic instrument/hardware

4.4.1 Installing the Display

Installing the display

① The display is located along with all other accessories in the small packaging box.



- 1. Install the rubber pad (\rightarrow "Fig. 9-1") on the instrument.
- Guide the cables of three terminals (power supply, USB port and display cable) through the hole on the bracket and then install the bracket (→ "Fig. 9-2") by fastening 8 screws at two sides. (→ "Fig. 9-3").
- Plug in three terminals (power supply, USB port and display cable) on the bottom of the display (→ "Fig. 9-4").
- 4. Install the display by fastening 4 screws at the back of the instrument (\rightarrow "Fig. 9-5") using spring washers and flat washers.

4.4.2 The retort

Open/Close the retort

- Turn the handle as shown in the below figure (\rightarrow "Fig. 10") and lift here (\rightarrow "Fig. 10-1") to open the retort. Do not try to pry the handle.
- To seal the retort, push the handle back to the place with strength.

The open/close status of the retort is displayed on the screen (\rightarrow P. 76 – Retort status).

Caution

 \wedge

Because of the hot surface, wear chemical protective clothing, protective goggles, respirator, rubber gloves and all other necessary personal protective equipment, and keep your distance when opening the retort lid, particularly if the reagents are heated. Also avoid breathing in the vapors.

Level sensor and retort sieve




There is a level sensor (\rightarrow "Fig. 11-1") located at the right side wall of the retort. It prevents the retort from being overfilled or insufficiently filled.

There is a retort sieve (\rightarrow "Fig. 11-2") at the bottom of the retort. Install the sieve by inserting and rotating it clockwise.

4.4.3 Active carbon filter



Inserting/Replacing the active carbon filter

1. To insert/replace the active carbon filter (\rightarrow "Fig. 12-1"), press and open the top cover (\rightarrow "Fig. 12-2") behind the retort lid.

Cautio

Putting hand in the active carbon filter container (\rightarrow "Fig. 12-6") may cause injury.

- For the first time to insert the active carbon filter, make sure that the arrows on the filter
 (→ "Fig. 12-4") and on the instrument (→ "Fig. 12-3") are at the same direction, and then push
 the new filter in as far as it will go. The date on which the filter has been inserted can be
 marked on the label (→ "Fig. 12-3") on the front side.
- 3. Close the top cover.

The instrument will calculate the time the active carbon filter has been in use.

• When the time exceeds the warning threshold, a warning pops up, reminding you to replace a new active carbon filter.

• When the time exceeds the alarm threshold, the alarm rings with a warning message. For how to set the warning/alarm threshold of the active carbon filter, see (\rightarrow P. 58 – 5.2.8 Maintenance).

Note

The exhausted vapors from the instrument is harmful. The active carbon filter must be in use.

The active carbon filter is only an additional measure to minimize harmful vapors in the area surrounding the instrument. Ventilation of the workroom is required in any case. The filter replacement is dependent on the frequency of using the instrument, but at least it needs to be replaced after 45 - 60 days.

4.4.4 External exhaust system

The instrument has been designed so that it can be connected to an external exhaust device. The optional delivery includes the "Extraction tube" (\rightarrow P. 98 – 8. Ordering information) for this purpose. It is recommended to use an external exhaust system.



Attach one end of the extraction tube (\rightarrow "Fig. 13-1") to the upwards-pointing tube of the flange and push it down as far as it will go. Connect the other end of the extraction tube with the external exhaust station.

Caution

Even if the instrument is connected to an external exhaust device, the active carbon filter provided must remain in use.

4.4.5 Counter area





To the right of the retort in front of the display, there is a counter area (\rightarrow "Fig. 14-1"). The flat area can be used for setting down the prepared specimens and baskets removed from the retort. However, we recommend also covering the counter area with a silicone pad (\rightarrow "Fig. 14-2"). For ordering information of the silicone pad, see (\rightarrow P. 98 – 8. Ordering information). To avoid reagent dripping, it is recommended to use a container on the silicone pad to hold the baskets.

Caution

<u>'!</u>\

The specimens and baskets may drop down if they are not set down at the flat area of the counter.



4.4.6 Cassette baskets

- The above figure (\rightarrow "Fig. 15") shows the standard stainless steel basket (\rightarrow "Fig. 15-1").
- The dividing spiral (\rightarrow "Fig. 15-2") is used to align the cassettes in the basket accurately.
- As shown with the dividing spiral, the standard basket can be filled with up to 80 specimen cassettes. Without a dividing spiral, the cassettes can be packed in more tightly, so that a maximum of 100 cassettes can fit in the basket.
- Each metal basket has a movable handle (\rightarrow "Fig. 15-3") for inserting and removing it from the retort.

- The lid (\rightarrow "Fig. 15-4") is added onto the baskets after being filled.
- Up to 2 baskets can be inserted into the retort and processed simultaneously.

⚠

Only clean baskets can be used for tissue processing.

Note

It is recommended to use Leica Biosystems predefined/validated consumable (cassettes).

Do not add more than 200 cassettes into the retort during processing.

4.4.7 The display

- The HistoCore PEARL is programmed and operated via a color LCD touchscreen.
- A screen saver will turn off the screen display if no key has been pressed for 30 minutes. Press any part of the touchscreen to restore the screen. After having been restored, the on-screen functions will be non-operational for a few seconds to avoid accidental touch of any keys.
- The touchscreen is fastened to a stable base with four screws. All terminals are protected from contact with reagents. The touchscreen itself is resistant to all reagents used in the instrument. Despite this, avoid any reagent contamination to the screen. Immediately wipe any reagent splashes!

4.4.8 The paraffin baths

- The instrument has three heated paraffin baths, each with a max. capacity of 3.5 L of liquid paraffin. They are located over the reagent cabinet.
- The individual paraffin baths can be pulled out (→ "Fig. 17-1") for filling and can also be removed from the paraffin oven for cleaning.



Caution

Be careful of the paraffin oven cover hinges. Open and close the oven cover only using the supplied handle (\rightarrow "Fig. 17-2"). Do not place fingers in the areas shown in the above figure (\rightarrow "Fig. 17-3").



Caution

Never attempt to forcefully remove the paraffin baths when the instrument is cold. Doing so can damage the instrument.



A Caution

Proceed slowly and carefully when pulling out a paraffin bath—never jerk it out. The paraffin inside is hot and can cause burns. The paraffin baths surfaces, handles and covers are also hot, therefore always wear chemical protective clothing, protective goggles, respirator, rubber gloves and all other necessary personal protective equipment, and proceed carefully.




Caution

Before use or after maintenance, check the paraffin baths to make sure there is no leakage.

• The baths need to be filled with liquid paraffin manually. It is also possible to fill with pellets - the melting time then is approximately 12 hours or 15 hours dependent on the paraffin bath temperature setting.

All paraffin baths have two handles (→ "Fig. 18-1") for pulling out and carrying. Two covers (→ "Fig. 18-2") (→ "Fig. 18-3") provide for better thermal insulation and prevent the liquid paraffin from spilling out when being pulled out.



- When pulling out a bath, both the front and the rear cover can be folded upwards each other (\rightarrow "Fig. 19") to facilitate filling and cleaning.
- The maximum and minimum filling levels are located on the interior walls. Make sure that the paraffin level is between these two marks.
- There is a filter(\rightarrow "Fig. 19-4") located in each paraffin bath, which can be taken out for easy cleaning.


4.4.9 The paraffin drip tray

- The paraffin drip tray (→ "Fig. 20") is located below the paraffin oven. It collects paraffin that have overflowed.
- The paraffin drip tray must be regularly checked and cleaned. To do so, pull the paraffin drip tray out by the handle and empty it.

4.4.10 Reagent cabinet with reagent bottles



- The 13 white plastic reagent bottles are located together with the condensate bottle (→ "Fig. 21-1") in the reagent cabinet under the 3 paraffin baths (→ "Fig. 21"). The numbering of the bottle positions are silk-screened on ribs of the reagent carbinet (→ "Fig. 21-2").
- The simulated reagent bottles are designated "1" to "13" on the top with the reagent name in the middle, and are displayed on the screen (→ "Fig. 22").
- All reagent bottles have a max. capacity of 3.5 L . The maximum (3.5 L) and minimum (3.3 L) fill levels for filling are embossed on the front of each bottle.



Pulling out a reagent bottle

- 1. Grasp the front handle (\rightarrow "Fig. 23-1") and pull out half of the bottle.
- 2. Grasp the top handle (\rightarrow "Fig. 23-2") and pull out the full length of the bottle.

Inserting a reagent bottle,

» When inserting a reagent bottle, always ensure that the retaining ring (\rightarrow "Fig. 23-3") is tightened and the connection port is pushed into place with a click sound (\rightarrow "Fig. 23-4").

The connection port must be pushed into place with a click sound, thus ensuring an optimum fit in the reagent cabinet.

Condensate bottle

- The condensate bottle (\rightarrow "Fig. 21-1") has the exact same shape and connection design as a reagent bottle.
- It captures and collects condensate that forms in the system. A mark for the maximum level is on the front side.
- Regularly check and empty the condensate bottle (\rightarrow P. 91 Emptying the condensate bottle).

4.4.11 The reagent drip tray and the bottom tray

The reagent drip tray and the bottom tray are located below the reagent cabinet. They collect reagents that have overflowed or spilled. The reagent trip tray volumn is approximately 1.4 L; the bottom tray volumn is approximately 4 L.

The reagent drip tray and the bottom tray must be regularly checked for signs of reagents that have leaked. To do so,

- pull the reagent drip tray out by the handle and empty it.
- use one hand to pull the bottom tray out by the handle until you see the etched number, 20 cm; use the other hand to support the tray from the bottom. Then pull out the whole bottom tray and empty it.

Caution

Dispose of waste reagent with care according to local regulations and the waste management policy of the company or institution.

4.4.12 Adhesive labels for reagent bottles

- The standard delivery of the HistoCore PEARL includes adhesive labels for the reagent bottles in the reagent cabinet. They can be used to mark the groups of the reagent bottles.
- Ensure the surface on the reagent bottles are clean and dry; then apply the label and press on firmly—especially at the edges.
- The labels are resistant to the reagents used in the instrument.
- The station number can be noted on the label as well as the date when the reagent specified in the color table was commissioned.

4.5 Alarm functions

Note

In the instrument, states can occur that require the attention of, or a decision on the part of, the user. In the simplest case, these are confirmations for continuing in the processing program. In addition, however, during continuous monitoring of the hardware, errors can be identified that must be eliminated as soon as possible for a running program to be finished successfully. Correspondingly, all messages are classified according to their severity.

The HistoCore PEARL is equipped with 3 different alarm functions:

Instrument alarm

This instrument alarm is generated from within the instrument itself for all alarm messages.

Local alarm

This alarm is external to the instrument, e.g. in the office of the instrument operator. The local alarm is used when the instrument cannot continue with the current program or operation because of a problem.

Remote alarm

This alarm is also external to the instrument. If installed, it can be connected to a remote alarm system that sends an alarm message to the person responsible for after-hours problems. The remote alarm is only generated when the instrument cannot continue with a program.



Note

The remote alarm will still operate even if the local alarm is not installed.

Connecting the local and remote alarm system

Note

Both local and remote alarm options are relays that are voltage-isolated from the rest of the instrument. When an error condition occurs, the relevant alarm circuit closes. The remote alarm device connected to the instrument must be rated at less than 1 A. A maximum voltage of 30 V DC may be present.

\land

Caution

Connection of an external alarm system (local and remote alarm) is absolutely necessary for preventing damage or loss of tissue samples in the event of a malfunction.

The alarm systems for the local alarm and remote alarm are connected via a 5-pin male M16 connector (Amphenol T3360001U as a reference for cable diameter 4-6mm).

The maximum values of the alarm system connected to the instrument must not exceed 30V DC, max. 1A.

Local alarm: socket (1) (\rightarrow "Fig. 25-1") Remote alarm: socket (2) (\rightarrow "Fig. 25-2") Each alarm is connected to the plug(6) as follows: Shared terminal: pin (1) (\rightarrow "Fig. 26") Normally open contact: pin (3) (\rightarrow "Fig. 26") Normally closed contact: pin (2) (\rightarrow "Fig. 26") Pin (4) (\rightarrow "Fig. 26") and pin (5) (\rightarrow "Fig. 26") shall be short-circuited.

4.6 Connecting the power supply

Caution

Observe the following instructions carefully to prevent damage to the instrument.

The instrument MUST be connected to a grounded power socket. The power plug must be easily accessible so that it can be pulled out if required.

The instrument is supplied with a set of different power cords. Use only the power cable that matches the local power supply (outlet).

Do not use an extension cable!

Check the nameplate on the rear of the instrument to ensure that the instrument delivered is designed for the required voltage.

Severe damage may occur if the instrument is connected to a power supply voltage other than that to which it was originally set.





4.7 Switching the instrument on

Cautio

The instrument MUST be connected to a grounded power socket.

For additional electrical fuse protection, we recommend connecting the HistoCore PEARL to a socket with a residual current circuit breaker.

Switching the instrument on

Screen saver

A screen saver will turn off the screen display if no key has been pressed for 30 minutes. Press any part of the touchscreen to restore the screen.

After having been restored, the on-screen functions will be non-operational for a few seconds to avoid accidental touch of any keys.







4.10 Moving the instrument

Caution

Before moving, switch off the instrument.

Before moving the instrument, the power cord must be disconnected from the power supply and the instrument is cooled down.

Before moving the instrument, make sure that no paraffin is in paraffin baths or the paraffin drip tray, and the paraffin oven cover is closed to protect paraffin baths from dropping during transportation. Or remove the paraffin baths from the instrument. The retort lid must be sealed as well.

To avoid dropping of the filled reagent bottles and damage to the reagent bottles or connectors, the reagent bottles must be empty or removed while moving.

Moving the instrument

- 1. Release the casters of the instrument.
- 2. Hold the handles at the rear panel and push the instrument to its new location.
- 3. Lock the casters after the instrument has reached the final position.

5. Operation

5.1 Access levels

The HistoCore PEARL has three access levels. The user level symbol (\rightarrow "Fig. 37-1") is displayed at the upper right corner of the touchscreen.


- Standard user (→ "Fig. 37-3") The Standard user is the default user level when you log on the
 instrument. It does not require a password. The Standard user can work with limited functions, such
 as running programs, viewing results, setting the status of reagents as emtpy or full, etc. The function



Setting the paraffin bath temperature

- ① Only Supervisor and Service user level can edit it.
- 1. Press the icon of System Setup (\rightarrow "Fig. 43-1").
- 2. Set the paraffin bath temperature, ranging from 50°C 70°C in 1°C increments (\rightarrow "Fig. 43-2"). The temperature unit and range is dependent on the settings in **Regional Settings** (\rightarrow P. 50 5.2.2 Regional Settings).

Note

It is recommended to set the paraffin baths temperature 2 °C higher than the maximum paraffin melting point provided in the paraffin manufacturer's specification. Otherwise, the paraffin that is not completely melted may cause a blockage in the air/liquid system.

If the paraffin baths temperature is set to above 64 °C, the melting time will take longer, approximately 15 hours.

If the paraffin bath temperature is set from a higher value to a lower value, an error code pops up. When it occurs, restart the instrument using the On/Off button on the back panel. If any error appears after the restart, please retry after several minutes. If the problem persists, call your local service representative.

Bottle Check function

The Bottle Check function checks the following:

- The connections between the reagent bottles and the instrument for leaks and blockages;
- Whether the reagent bottles are filled or empty.
- To start the Bottle Check function, press the Bottle Check button (\rightarrow "Fig. 43-3").

Follow the instructions on the pop-up messages. If the Bottle Check is completed successful, the instrument is ready to start a program. If the Bottle Check fails, follow the instructions on the pop-up messages. If the Bottle check is interrupted, for example by the power failure, restart the Bottle Check when the power is restored.



- Checkbox "Direct Connection" (→ "Fig. 47-2"): The check box "Direct Connection" determines whether a direct connection to the Leica RemoteCare service or to a "proxy server" shall be used. If the instrument shall connect the RemoteCare server directly, please check the "Direct Connection" check box. If selected, the proxy settings underneath it will be greyed out. This is the standard connection method. If a proxy server shall be used, uncheck the "Direct Connection" checkbox and set the proxy parameters (Proxy User Name, Proxy Password, ProxyIP Address and Proxy Port).

Editing Remote Care parameters

- Only Supervisor and Service user level can edit Remote Care parameters whilst there is not a program running.
- ① Make sure that the instrument is connected to the network.
- 1. Press Network (\rightarrow "Fig. 47-1").
- Uncheck Direct Connection (→ "Fig. 47-2"), and the proxy parameters fields are enabled (→ "Fig. 47-3").

5.3.4 RMS

The HistoCore PEARL has a Reagent Management System (RMS) that ensures optimized reagent consumption and the best possible tissue processing results. The Reagent Management System is controlled via warning threshold values that display the reagent replacement. For each reagent, a value of this type can be defined depending on the use.

RMS mode

The RMS is divided into 2 groups, Processing Reagents and Cleaning Reagents.

For Processing Reagents, the following 4 modes are available.

- Off- The RMS mode of the processing reagents turns off.
- Cassettes Number of processed cassettes
- Cycles Number of cycles (1 processed program = 1 cycle)
- Days Days until changing the reagent

For Cleaning Reagents, the following 3 modes are available.

• Off- The RMS mode of the cleaning reagents turns off.

- Cycles Number of cycles (1 processed program = 1 cycle)
- Days Days until changing the reagent

The RMS is enabled by entering warning threshold values for one of these parameters specified above and is displayed in the reagents **Status**.

Note

If the RMS is set to be Off, the reagent consumption status can not be monitored, which may impact the tissue processing quality. The pre-installed programs can not run, either.

Reagent warning messages

If the RMS is enabled, the following indicates that the warning threshold values have been exceeded.

- The exceeded bottle turns to red and blinks. The operator is notified that the reagent has exceeded and can replace this reagent before the program starts. However it is possible to start the program if logged in at Supervisor level. Always replace the reagents when the threshold is reached.
- The exceeded bottle turns to red and flashes at the end of a program (after the cleaning). You can go directly to the reagent Status window.
- The reagent status highlights the exceeded values in red in the table.

Cautio

Longer than the recommended use of cleaning reagents can cause paraffin blockage in reagent tubes.

Changing the threshold value to more than recommonded, may impact the tissue processing quality.



5.4 Program

The Program list shows all programs defined in the HistoCore PEARL.

These programs include

- 1 Cleaning program
- 2 pre-installed programs, Overnight and Biopsy
- Up to 10 customized programs created by users at the Supervisor level.

At the Standard user level or when a program is running, the menu Program is in view mode.

At the Supervisor or Service level, and if no program is running, the menu Program is in edit mode. The customized programs can be added, deleted or edited by Supervisor.

HistoCore PEARL is normally used in sequential mode, which means that the instrument uses one bottle after the other.

Note

The pre-installed processing programs and Cleaning program are preset and listed on the top of the user programs. They cannot be renamed, edited or deleted.

The pre-installed programs can be copied. The copied program is renamed automatically. For more information, see below section (\rightarrow P. 69 – Creating a new program).

All customized processing programs and RMS (Reagent Management System) have to be validated by the user before running the program, i.e. tissue processing with patient tissue for diagnostics, according to the local or regional accreditation requirements.





On the dashboard displays the retort status (\rightarrow "Fig. 61-1"), paraffin baths status (\rightarrow "Fig. 61-2"), reagents status (\rightarrow "Fig. 61-3"), a list of favorite programs (\rightarrow "Fig. 61-4") and program running status, buttons of start/pause/abort (\rightarrow "Fig. 61-5"), and shows the seal/unseal status of retort lid.



A filling animation is displayed when the retort is filling/draining reagents. The retort filling grows from empty to full during sucking; the retort filling decreases from full to empty during draining.

Do not open the retort when the program is running. It may damage the specimens.



The paraffin baths are filled with paraffin group color, and named with Paraffin (1), Paraffin (2) and Paraffin (3).

The paraffin baths have the following status:

- Empty (\rightarrow "Fig. 63-1") The paraffin bath is empty.
- Partially filled (\rightarrow "Fig. 63-2") The retort is sucking/draining the paraffin.
- Full (\rightarrow "Fig. 63-3") The paraffin bath is full.
- Blinking (\rightarrow "Fig. 63-4") The paraffin is expired, when the RMS is on.
- Not displayed The paraffin bath is not used in the selected program.

A filling animation is displayed when the retort is sucking/draining paraffin. Paraffin bath filling decreases from full to empty, when the retort is sucking the paraffin; paraffin bath filling grows from empty to full, when the retort is draining the paraffin back.

A filling animation is displayed when the retort is sucking/draining a reagent. Reagent bottle filling decreases from full to empty, when the retort is sucking a reagent; reagent bottle filling grows from empty to full, when the retort is draining the reagent back.

Program list panel is displayed when no program is running (\rightarrow "Fig. 66-1"). It is switched to the program running panel after a selected program starts (\rightarrow "Fig. 66-2").

If a program is selected, the program icon and name is highlighted (\rightarrow "Fig. 66-3").

Maximum 5 favorite programs can be shown in the program list panel. For how to set a program as a favorite program, see (\rightarrow P. 74 – 5.4.2 Favorite programs).

5.6 Reagent handling

5.6.1 Filling/draining reagents

Cautio

The following steps should only be carried out by trained laboratory personnel, experienced in handling reagents.

Always wear chemical protective clothing, protective goggles, respirator, rubber gloves and all other necessary personal protective equipment, when handling the reagents used in this instrument. Reagents used for tissue processing can be both toxic and/or flammable.

Caution

⚠

Dispose of waste reagent with care according to local regulations and the waste management policy of the company or institution.



Changing the reagents

- ① Never replace reagents or fill empty reagent bottles while a process is running. This can result in severe damage to the instrument.
- ③ Make sure that the reagent bottles are placed in the correct position according to the reagent definition on the display. For reagent positions, see (→ P. 21 3.5.1 Cycle for changing reagents).
- 1. Remove the reagent bottle from the reagent cabinet and unscrew the bottle cover (\rightarrow "Fig. 67-1").
- 2. Drain the used reagent into a bulk container.
- 3. Clean the reagent bottle sufficiently before refilling.
- 4. Refill the reagent bottle. The maximum and minimum fill levels for filling are embossed on the front of each bottle. Use a funnel for clean filling.



Note

Check the reagent level in the reagent bottle on flat ground. To do so, keep your eye-sight and the reagent level at the same level, and make sure that the volume of the reagent is not either more than the max. level or lower than the min. level. The insufficient reagent may cause the specimen to dry out due to the specimen not being covered by sufficient reagents.

- Place the filled reagent bottle back in the reagent cabinet. When inserting the reagent bottle, always make sure that the retaining ring (→ "Fig. 67-2") is securely tightened and the connection port (→ "Fig. 67-3") clicks into the back panel correctly.
- 6. In the reagent status window, reset the data. For more information, see (\rightarrow P. 61 5.3.1 Reagent status).

5.6.2 Filling/refilling paraffin

There are two marks on the interior wall of the paraffin bath that display the maximum and minimum filling level when filled with paraffin. The level must be between these marks. The paraffin bath can be filled with paraffin pellets, paraffin blocks or liquid paraffin.

If the paraffin baths temperature is set to below 64 °C, or at 64 °C, the melting time is approximately 12 hours. If the paraffin baths temperature is set higher than 64 °C, the melting time takes longer, approximately 3 additional hours. For setting the paraffin baths temperature, see (\rightarrow P. 55 – 5.2.6 System Setup).

For each paraffin bath, 2.8 kg-3.0 kg of the paraffin pellets are required.

Fill the paraffin bath to the brim with pellets. The paraffin will need to be topped up with additional pellets within 6 hours.

Make sure that the paraffin has completely melted after being replaced, prior to use.

Note

If pellets were added 6 hours after the initial paraffin refill, they may not be melted completely before use and an error message would be triggered which may cause the instrument to stop heating.



If the pellets were added, make sure that the paraffin is completely melted before starting a program.

Refilling paraffin

- 1. Open the paraffin oven cover. A message pops up on the screen, and asks if you want to refill the paraffin.
- 2. Press Yes, the system will calculate the melting time. If it is to run a processing program, make sure that the time length before the paraffin step is longer than 12 hours. If the time length is less than 12 hours, the Formalin step will be delayed so that the melting time of 12 hours is completed. If the melted paraffin is added, press No, and the system will not calculate the melting time. You must check the melting status of the paraffin, prior to use.



Press Yes first on the pop-up message box before adding the solid paraffin. There is a risk of blocking the instrument if the paraffin is not completely melted.

3. Pull the paraffin bath out from the paraffin oven.



A Caution

Proceed slowly and carefully when pulling out or removing a paraffin bath-never jerk it out. The paraffin inside is hot and can cause burns. The paraffin baths surface are also hot, therefore always wear chemical protective clothing, protective goggles, respirator, rubber gloves and all other necessary personal protective equipment during exchanging or adding paraffin.

4. Drain the used paraffin into a bulk container and then refill the bath. The maximum and minimum levels for filling is in the interior wall of the paraffin bath.



Note

Remove the residue of the paraffin or dirts before refilling the paraffin.

5. Place the filled paraffin bath back in the paraffin oven. When inserting the paraffin bath, always make sure that it slides back through the sliding slot and connects into the back panel correctly.



Note

It is recommended to refill the paraffin bath one by one.

6. In the reagent status window, reset the data. For more information, see (\rightarrow P. 61 – 5.3.1 Reagent status).



Note

If the paraffin baths are refilled with paraffin of different melting points, empty and clean the paraffin baths and the filter. After refilling, reset the melting point of the paraffin baths, for more information, see the section of System Setup (\rightarrow P. 55 – 5.2.6 System Setup).

5.7 Starting a program

Before a program can be started, a number of conditions must be met. The following steps are essential in order to be able to start a program.



Caution

- Before switching the instrument on, visually check the instrument and accessories for any damages possibly caused during transportation or moving the instrument. Do not operate the instrument and contact your local service representative if you find or suspect any damage.
- Before processing patient tissue samples after transportation or moving the instrument, perform a test
 run to ensure the suitability of the instrument and the program used. Either use a pre-installed program
 or combine this activity with the validation of your own protocols. Only process patient tissue samples
 for diagnostic purpose, after all above checks have been performed successfully. If any of the previous
 steps failed, contact your local service representative.

⚠

Caution

The pre-installed programs, the customized processing programs and RMS (Reagent Management System) have to be validated by the user before running the program, i.e. tissue processing with patient tissue for diagnostics, according to the local or regional accreditation requirements.

\wedge

Check the reagent levels and the paraffin levels before starting a program. To do so, keep your eye-sight and the reagent/paraffin level at the same level, and make sure that the volume of the reagent/paraffin is not either more than the max. level or lower than the min. level. The insufficient reagent/paraffin may cause the specimen to dry out due to the specimen not being covered by sufficient reagents/paraffin. Check that the reagent bottles and paraffin baths are correctly inserted.



Caution

Make sure that the simulation of the reagent bottles on the display and the reagent bottles in the reagent cabinet are correctly matched.

Caution

Check that the retort sieve is correctly installed at the bottom of the retort, then make sure that the retort lid is sealed before a program starts.

Starting a program

- 1. Make sure that the correct paraffin melting temperature has been set in the system settings (\rightarrow P. 50 5.2 Setting up system).
- 2. It is recommended to run the Bottle Check after the reagents/paraffin are refreshed. For how to run a Bottle Check, see the section of System Setup (\rightarrow P. 55 5.2.6 System Setup).



Caution

- Not running Bottle Check function may cause tissue damage due to blockage or leakage, or lack of reagents.
- If the retort is contaminated by the reagents/paraffin, the Bottle Check function will be disabled to avoid tube blockage.
- Before running the Bottle Check, make sure that the retort is empty, clean and dry. Otherwise, the contamination in retort may occur and impact the tissue processing quality.
- 3. Put the baskets in the retort.

Note

Use the basket during processing. Do not put the specimens into the retort directly. Carefully handle the specimens and place into a cassette to avoid dropping into the retort sieve holes.

- 4. Select a program in the program list panel. The selected program name and the icon are highlighted. Please double check that the highlighted program is the correct program that you want to run. Then press **Start**.
- 5. If RMS is set On and Cassette mode is selected, the following box pops up (\rightarrow "Fig. 68").

6. Select the cassette number and press **OK**. The **End Time of Program** window (\rightarrow "Fig. 69") pops up. The default end time (\rightarrow "Fig. 69-1") for the selected program is shown.

7. Set the day and the time (in 24-hour format) (\rightarrow "Fig. 69-2") on which you want the program to end.



Note

The date sequence is Day-Month-Year.

8. Press OK (\rightarrow "Fig. 69-3").



Note

If the first reagent in the program belongs to the fixation group, programs can be started up to 7 days in advance. If the program is ended at a defined date/time, the delay step is lengthened accordingly.

» Or if you do not set the end time, press ASAP (→ "Fig. 69-4") and then press Run (→ "Fig. 69-3"). The program starts. The Dashboard is switched to the program running panel.

Note

After press ASAP, the Endtime field (\rightarrow "Fig. 69-1") is displayed as ASAP, and the OK button changes to Run.



Caution

Monitor the instrument during Pre-checking and formalin soaking in the retort, in case any message pops up.



Caution

Do not open the retort lid or pull the reagent bottles/paraffin oven cover/paraffin baths when a program is running. It may cause damage to the instrument or trigger an error reporting.



Caution

Whilst a program is running, if you want to remove the specimens from the retort or add specimens to the retort, press the pause button.

Loaded specimens/baskets must not be higher than the level sensor, to ensure that they will always be covered by reagent.

Note

If you want to add more cassettes when the program is running and the tissue is soaking in Formalin, pause the program and make sure to wear chemical protective clothing, protective goggles, respirator, rubber gloves and all other necessary personal protective equipment to add the cassettes. The Standard user can only pause the program at the first 3 steps, and abort the program at the first step. The Supervisor can pause or abort the program at any step.


After pausing, please be aware of the finish time of the processing program.

If the RMS is set to be in Cassettes mode, input the number of the newly-added cassettes. The number can not be 0, and the total number of the cassettes in the retort can not exceed 200.

If no cassette is added, press Cancel.

Press the **Start** button to continue the program, and make sure that the retort lid is sealed after cassettes are added.

- The icon and name of the program which is running (\rightarrow "Fig. 70-1")
- The name of the step which is running (\rightarrow "Fig. 70-2")
- The step remaining time (→ "Fig. 70-3"). The step time is the total time of filling, soaking/infiltration and draining.
- The program remaining time (\rightarrow "Fig. 70-4")
- The end date and time (\rightarrow "Fig. 70-5")
- Program Details button (\rightarrow "Fig. 70-6"). Press Program Details to view the program details (\rightarrow "Fig. 71").
- Pause button (→ "Fig. 70-7"). At the Standard user level, the pause button is only enabled during the first 3 program steps; at Supervisor/Service level, the pause button is enabled at any time within the program.

- Close button (\rightarrow "Fig. 71-11"). Press Close to close the program details window.

Note

The Step time (\rightarrow "Fig. 71-3") and the Remaining time (\rightarrow "Fig. 71-4") may not match at the last step. The instrument may carry out self calibrating during this time.



Caution

Always wear chemical protective clothing, protective goggles, respirator, rubber gloves and all other necessary personal protective equipment, if it is necessary to open the retort whilst a program is running.

Note

When it is necessary to pause the program, press the pause button and wait till the current step (filling or draining) finishes. When the **Start** button is enabled, operate the instrument then, for example, open the retort lid to remove the cassettes. To continue with the program, press **Start**.



Caution

Make sure that the retort lid is sealed when the program starts. Do not open the retort lid when a program is running.

5.8 Ending a program

When a program is completed, a message pops up , indicating that "The program is finished. Would you like to drain the paraffin?" Press **OK**, and the instrument starts to drain the paraffin. After the paraffin is drained, another message pops up, indicating that you can take out the basket. After the basket is taken out and the retort lid is sealed, the third message box pops up, indicating that the retort is contaminated and please run the Cleaning program. Insert the empty baskets and run the Cleaning program.



Caution

The baskets are hot. Wear gloves when taking out the baskets.

5.9 Pre-installed program

The permanently installed programs described below have to be validated before use, i.e. tissue processing using patient tissue for diagnostics, by the laboratory itself based on tissues that are not intended for diagnostics and in accordance with local or regional accreditation requirements.

The two pre-installed programs above cannot be edited or deleted, they can be copied.

6. Cleaning and maintenance

6.1 Cleaning program

Note

The Cleaning program is a pre-installed program.

The Cleaning program cannot be edited, copied or deleted.

The Cleaning program is offered automatically when an infiltration program has been completed. In this case, a retort cleaning cycle MUST be carried out; this function cannot be canceled.

Use only the recommended reagents.

Running Cleaning program

The Cleaning program skips any steps not required to complete the cleaning of the retort.

- If the last step of a processing program is Formalin, Processing Water or Alcohol, the Cleaning Program will not run after the processing program completes.
- If the last step of a processing program is Xylene or Paraffin, the cleaning program will run after the program completes.



/!\

Caution

Do not open the retort lid during the Dry step of the cleaning program.

The Pathology Company

Caution

Do not pull the reagent bottles when the cleaning program is running. It may cause damage to the instrument or trigger an error reporting.

Caution

Baskets can be cleaned together in the retort. ONLY completely cleaned baskets can be used for tissue processing. After a maximum of 5 cleaning cycles, cleaning xylene and cleaning alcohol must be replaced. Neither drip trays nor other objects can be cleaned using the HistoCore PEARL Cleaning program!

• After you touch the **OK** button, a message appears indicating that before the cleaning is started the retort must be empty and all specimens have to be removed.

- When all necessary conditions have been satisfied, press the **Start** button. Wait about 8 seconds, and the cleaning program starts. The procedure is displayed graphically on the Dashboard.
- After the cleaning program has been completed, a message appears on the screen if the temperature in the retort is high. Open the retort lid and wait for a few minutes to let it cool down.

Cleaning reagent warning message

If RMS is enabled, the following indicates that the warning threshold values have been exceeded.

- The exceeded bottle turns to red and flashes. The operator is notified that the reagent has exceeded and can replace this reagent before the program starts. However, it is also possible to start the program despite this at Supervisor level.
- The exceeded bottle turns to red and flashes at the end of a program (after the cleaning). You can go directly to the reagent Status window.
- The reagent status highlights the exceeded values in red.

Cau

Follow the RMS reminder. Continuously reusing the expired cleaning reagents may lead to bad quality of the Cleaning program and may cause damage to the instrument or trigger an error reporting.

6.2 General instrument cleaning

6.2.1 Daily cleaning and maintenance

Instrument exterior

Clean the housing (including the instrument exterior, display, retort lid, counter area, etc) and the ground if contaminated by reagent. Wipe with a damp lint-free cloth moistened with mild detergent and dry.



Caution

Do not use solvents on painted surfaces, warning labels or the touchscreen.

To avoid scratching the surface of the instrument only the paraffin scraper that is supplied with the instrument should be used for cleaning – Do not use metal tools!

Cleaning the retort lid

Remove paraffin from the inside of the retort lid with the plastic scraper provided. Thoroughly remove all paraffin deposits from around the lid seal.



Caution

Only use the plastic scraper provided when cleaning the retort lid and seal to avoid damage to the retort lid seal. Do not damage the edges of the seal with the scraper.

Cleaning the retort

• Wipe the retort using a lint-free cloth moistened with solvent (xylene or alcohol) or mild detergent.

 Remove residues of paraffin and reagent from the retort inside wall higher than the reagent level area and the area around the retort (→ "Fig. 73") after each cleaning program.

• Make sure that the air vent holes at the top front of the retort are not dirty.

Cleaning the level sensor

) Note

The level sensor must be cleaned of all residue (reagents and paraffin).

Use a lint-free cloth to clean the level sensor.

Checking the reagent drip tray and bottom tray

🔨 Cauti

Some of the reagents used in the HistoCore PEARL are hazardous to health. Therefore always wear chemical protective clothing, protective goggles, respirator, rubber gloves and all other necessary personal protective equipment, when handling them.

The reagent drip tray and the bottom tray must be inspected regularly for signs of leaking reagents. It is recommended to do this after the processing program and cleaning program has been completed, before any leaking reagent has a chance to evaporate.

To check the reagent drip tray, pull the tray out by the handle.

To check the bottom tray, use one hand to pull the bottom tray out by the handle until you see the etched number, 20 cm; use the other hand to support the tray from the bottom. Then pull out the whole bottom tray.

Cleaning the paraffin drip tray

Caution

Use care with paraffin - risk of burning when removing the paraffin drip tray due to liquid paraffin.

- Pull out the paraffin drip tray. Empty the paraffin drip tray with the supplied scraper.
- If necessary place it in the laboratory oven (on cellulose) and clean with xylene substitute.

6.2.2 Weekly cleaning and maintenance

Cleaning the paraffin baths



Caution

Work carefully and wear gloves!

Be careful as the walls of the paraffin baths are very hot and may cause burns!

- Wipe the paraffin baths and the lids using a lint-free cloth moistened with solvent (xylene or paraffin remover).
- The lid can be removed for cleaning purposes.
- If they are very dirty, remove the paraffin filters from the paraffin baths. Clean, dry, and reinsert them.
- The paraffin bath seals must be replaced yearly. Contact Leica Biosystems Technical Service for the replacement service.

Emptying the condensate bottle

The condensate bottle must be taken out, emptied and reinserted weekly. This should be done sooner if a prompt to that effect is issued by the software.



Caution

Dispose of waste solvents with care according to local regulations and the waste management policy of the company or institution.

Cleaning the retort sieve

Use alcohol or xylene to clean the sieve located at the bottom of the retort. For convenience, the sieve may be taken out to remove all solid dirt.



Note

Make sure that nothing falls into the drain hole when the sieve is removed for cleaning purpose.

Checking the retort lid seal

Regularly check the retort lid seal for damage. If the seal is damaged, it must be replaced without delay. The retort lid sealing must be inspected at least once a year. Contact Leica Biosystems Technical Service for the inspection/replacement service.

Cleaning the display

Clean the screen using a lint-free cloth.



Note

The touchscreen may be triggered during cleaning. Clean the touchscreen whilst there is not a program currently running.

6.2.3 Monthly cleaning and maintenance

Replacing the active carbon filter

- The life of the active carbon filter will depend on the reagent types used and the frequency of vacuum cycles.
- The filter should be replaced every 45 60 days (45 days, warning threshold; 60 days, alarm threshold). After replacing the filter, open the maintenances menu to reset the filter threshold. For additional information, see (→ P. 58 5.2.8 Maintenance).



Note

When inserting the new filter, make sure that the arrows on the filter and on the instrument are in the same direction. It is inserted with the correct side up, as specified on the label on the front side of the filter, see (\rightarrow P. 31 – 4.4.3 Active carbon filter) for detailed information.

Cleaning the reagent bottle

• Empty and clean the reagent bottles, using a bottle brush in warm water. Wait till they dry and rinse the reagent bottles with corresponding reagents.



Note

The level can be identified by simply looking through the reagent bottles if these are cleaned regularly to remove clinging contamination.

Caution

Never clean reagent bottles in an automatic dishwasher. The reagent containers are NOT dishwasher-proof!

Care of reagent and condensate bottle seals.

- To ensure easy removal of the reagent and condensate bottles, lubricate the O-ring seals on the plugin nozzles with the O-ring lubricant supplied.
- Refill and reconnect the bottles once cleaned. Make sure the bottle lids are tight and the bottles are properly seated in their home position at the rear of the reagent module.

Caution

/!\

The reagent bottles must be properly engaged in the home position in the connection manifolds at the rear inner wall of the reagent module. Failure to correctly plug reagent containers into the manifold will cause an interruption to the processing run and may result in spilling of reagents.

• While the reagent bottles are outside of the reagent cabinet, wipe the stainless steel inner walls of the reagent cabinet with a lint-free cloth moistened with a mild detergent.

Cleaning the paraffin oven



Caution

Switch off the instrument before cleaning the paraffin oven.

Work carefully and wear chemical protective clothing, protective goggles, respirator, rubber gloves and all other necessary personal protective equipment!

Be careful as the walls of the paraffin oven are very hot and may cause burns!

- Wipe the paraffin oven using a lint-free cloth.
- Check the paraffin oven cover seal and clean it with a lint-free cloth.

6.2.4 Recommended cleaning reagents

The following reagents can be used for external (the top, sidewalls and the front)cleaning of the instrument.

- 1% HCI Alcohol
- Paraffin remover (i.e.Medite)
- Aqua Dest. Desinfection (Incidin)
- Paraguard (Polyscience)

7. Troubleshooting

7.1 Troubleshooting

When a problem occurs with the HistoCore PEARL, take the following steps to diagnose the problem:

- 1. Read the error message(s).
- 2. Follow the instructions on the message.
- 3. Check the Run Log for any messages that indicate the nature of the failure. If the failure occurred during a program run, check the Run Log for an indication of whether the failure occurred during the fill, processing or drain cycles, and the station in use at the time.

7.2 Power failures

If there is evidence of a power failure to the instrument:

- Verify that the power plug is plugged into the socket and that the socket is switched ON.
- Verify that the power switches on the rear of the instrument (adjacent to the power lead) is switched ON.
- Disconnect the instrument from the power supply, take out the main fuses and check them for continuity. In case of discontinuity, replace them with fuses of the correct value, reinsert them and reconnect the power cable. For how to replacing the fuse, see (→ P. 97 – 7.4 Replacing a fuse).



Note

If you cannot identify the problem by carrying out the above listed steps, call Leica Biosystems Technical Service.

Caution

If the instrument detects a power failure, the heaters and the display are immediately switched off.

The objective in case of power failure is to secure the tissue samples in a currently running program. The main emphasis is on the safety of the tissue samples, not the speed of processing.

In the event of a power failure, local alarm and remote alarm are triggered off.

After the power is restored, a message box is displayed, instructing the user to take out the specimens. If no operation is taken to the instrument with 5 minutes after the message box appears, the system starts reheating and the specimens are then safeguarded by filling the retort with a safe reagent. If the power can not be restored in time, remove the specimens and put them into a corresponding safe reagent. Check which bottle is running when the power fails. After the power is restored, check if the paraffin is melted or not, set a program and reprocess the specimens.

Note

The property of a safe reagent is that the specimen can stay in it for a long time without being damaged. An individual safe reagent is assigned to each program step/reagent group.

If no program is running when a power failure is detected, after the power is restored, the instrument is in standby.

7.3 Malfunctions in the program sequence

7.3.1 Safe reagent

Maintaining the specimen in a safe state is the primary concern during a malfunction. A safe specimen state is initiated following any power outage or malfunction where the processing program cannot be automatically finished. A processing program that has been started and cannot be finished automatically leads to a safe specimen state being initiated. The safe reagent process ends with one of the following results.

• Safe reagent filling process has been completed successfully. The specimens are being protected by safe reagent.

• Safe reagent filling process is finished but with warning information, which means the safe reagent may be insufficient.



Caution

Open the retort lid and visually check the safe reagent level in the retort. If the safe reagent level is insufficient, close the retort lid and drain the reagent, then fill the safe reagent bottle to sufficient.

• Safe reagent filling process fails. Please call service.

7.3.2 Crash or freeze of master software

Follow below steps to protect the specimens.

- 1. Take out specimens from the retort.
- 2. Restart the instrument. If the problem still exists, call Leica Biosystems Technical Service.

7.4 Replacing a fuse



Caution

Before replacing a fuse, switch the instrument off and pull out the power plug. Use ONLY the fuses with correct value. Fuse rating: T15 A, 250 V AC

Replacing a fuse

- ① A suitable flat-head screwdriver must be used to prevent damage to the fuse holders.
- Unscrew the two fuse holders (→ "Fig. 77-1") at the rear panel of the instrument with a flathead screwdriver and check for damage.
- 2. Remove the defective fuse from the holder and replace it with a new one.
- 3. Install the fuse holders back to the rear panel with the flat-head screwdriver.
