GUARANTEES:

1- That the lighting material listed below for the aforementioned works is manufactured using new materials of the highest quality, free of the hazardous substances restricted by European Directive 2011/65/EC (RoHS) and complying with electrical safety and electromagnetic compatibility standards applicable under European Directives 2014/35/EU and 2014/30/EU, as well as the REBT (Low Voltage Electro-technical Regulation) and the Energy Efficiency Law.

- 2- That C. & G. CARANDINI, S.A.U. has the technical and human means necessary to guarantee that stated in the previous paragraph, having implemented a quality management system that complies with standard ISO 9001/2015, and which has been in effect without interruption since October 1994, as well as an Environmental Management System in accordance with standard ISO-14001-2015, both certified by AENOR.
- 3- That the luminaires above mentioned have the following warranties:

- Warranty against all manufacturing defects for all mechanical, internal, and external components and aptness for the function they fulfil over a period of 5 years.

- Warranty against all manufacturing defects for the LED module and its gear for a period of 5 years, for a useful life parameter for the LED module L80B10 (4200 hours/year).

- Warranty for supply of original spares for maintenance operations for 10 years. Should any of the components likely to be replaced have disappeared from the market, C. & G. CARANDINI, S.A.U. undertakes to supply others of at least equal characteristics, performance, and quality to the original.

This Warranty shall apply from the delivery date given on our delivery notes and may be made effective whenever:

The environmental conditions correspond to those specified for the products described in this Warranty by Carandini, as well as those declared by the client for the works for which the guaranteed product is intended. Likewise, the electrical conditions also correspond to the limits regulated by local laws, the nominal laws declared by Carandini for the products indicated in this Warranty, and the regular and systemised implementation of the appropriate preventive maintenance.





Certificate of Warranty

This Warranty does not include devices with E-PROTEC protection, additional Control Systems such as remote management, or any other device or component unrelated to the standard Carandini configuration. These devices and/or components will be covered by a Warranty provided by their manufacturer. Also excluded from this Warranty are any elements and/or accessories added to the product after its delivery, as well as any faults that these elements might have caused, either directly or indirectly, to the correct operation of the luminaire, any of its components or the installation itself, or any kind of handling not expressly authorized beforehand by Carandini.

This Warranty will only be enforceable by the mutual agreement of both parties once it has been determined that the fault has not been caused by anything outside the characteristics and features declared by Carandini and/or agreed with the Client. Any other Warranty or compensation for damages is excluded.
