Stand Construction Services for Expo Real 2025 for the Promotion of the Investment Image of the Republic of Moldova and Investment Attraction

#### 1. Title of the Service:

Design, Construction, Assembly, and Dismantling of the National Stand of the Republic of Moldova at Expo Real 2025 (Cod CPV: 79951000-5).

### 2. Purpose of the Procurement:

The purpose of this procurement is to contract a professional company for the Design, construction, full installation, and dismantling of a stand on 24 m<sup>2</sup> exhibition space for the Republic of Moldova at Expo Real 2025 (held on the 06 – 08 October), to be held in Munich, Germany, in October 2025. The stand must reflect Moldova's investment attractiveness and provide an optimal space for B2B and promotional activities.

# 3. General Objectives:

- To build a visually attractive and functional national stand representing Moldova at Expo Real 2025.
- To ensure the stand is aligned with Moldova's country branding and investment promotion strategy.
- To create a space that facilitates business meetings, presentations, and promotional materials distribution.
- To ensure a high-quality and timely delivery of construction and dismantling services.

## 4. Requirements for the Company:

- Proven experience in designing and constructing exhibition stands for international fairs (minimum 5 international fairs in the last 2 years);
- Ability to implement construction services in the European Union, preferably with experience at Expo Real;
- Financial and technical capacity to deliver a turnkey stand project;
- Compliance with Messe München's technical and safety regulations.
- Possession of necessary permits, insurance, and compliance with labor and safety standards.

### 5. Activities to be Carried Out:

- Stand design concept creation in line with Invest Moldova Agency's branding and visual identity.
- Coordination with Messe München for technical compliance and space utilization.
- Construction and installation of the stand (including flooring, walls, lighting, furniture, storage space, and branding elements).
- Provision and setup of audiovisual equipment (screens, electrical outlets, lighting).
- Cleaning of the stand before its first time usage by the exhibitor.
- On-site logistical support during installation and dismantling.
- Dismantling and removal of all stand components at the end of the fair.
- Delivery of final photos and documentation upon completion.

## 6. Requirments for the stand:

- Print on fabric (for branding and graphic walls)
- LED lighting, including:
- Standard LED light fixtures
- LED lights mounted on busbar system (for flexible spotlighting)
- Plexiglass (plexi) elements (for signage or design accents)
- Laminated board (for walls, counters, or furniture finishes)
- Wood components (for construction or decorative elements)
- Plywood (for internal structures or partitions)
- TV screen 65" (for multimedia display)
- Carpet flooring (entire stand area)
- Live plants (for decor and natural ambiance)
- Layout and Functional Zones
- Meeting area with tables and comfortable chairs for business discussions
- Central high table designed for tastings and informal interactions
- Designated back area used for storage and operational support
- 9 boxes of 6 glasses each
- Trash can

# 7. Deliverables and Obligations:

- Detailed 3D design proposal and technical plan (to be approved by Invest Moldova Agency).
- Fully constructed and equipped stand delivered no later than one day before the fair opens.
- On-site support during the setup and dismantling periods.
- Final dismantling of the stand and restoration of the exhibition space to its original state.
- Final report including photos, description of activities, and proof of delivery.

### 8. Contract Duration:

The contract shall be valid from the signing date until the full dismantling and reporting are completed, no later than October 31, 2025.
