

POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS THAT WE THE PARTY whose details are given hereunder:

10. We, all the members of Lead firm undertake that we shall not cancel or amend this agreement unilaterally and without the consent of the CLIENT and such consent will be obtained in writing.

It is already understood that the Lead party /Leader shall ensure performance of the contract(s) and if one or more above said party (Member) fail to perform their respective portion of the Contract (s) the same shall be deemed to be a default by all the above said parties

It is expressly understood that this Power of Attorney shall remain valid binding and irrevocable till completion of the Warranty period in terms of the Contract. All the parties/members of above said hereby agrees and undertakes to ratify and confirm all the whatsoever the said Attorney/Authorized Representative/Leader quotes in the bid, negotiates and signs the Contract/other necessary documents, with the CLIENT and /or proposes to act on behalf of the Lead firm by virtue of this power of Attorney/Agreement and the same shall bind the said Lead firm and its authorized representatives, as if done by itself.
