#### Programme of the development of local suppliers

### LETTER OF INTENT

In this letter we express our intention to deliver services for CPV code 79400000-8, Lot 1.

Business Excellence CONSULTING s.r.o. has been founded in March 2006 by Vladimir Braun as continuation of his consulting career, which has started at KPMG Consulting in 2000.

Vladimir Braun acted as Project Manager of KPMG team at two Supplier Development Programmes administered by government agency CzechInvest in Czech Republic. The SDP was originally proposed to Czech Government by the World Bank. KPMG team delivered all field work starting by cooperation on supplier selection and including first business reviews of suppliers, improvement action planning and second business reviews including proposal of short listed suppliers for further support after second BRs. Specific methodology for assessment, based on EFQM Model together with requirements of Multinational Companies has been developed during first SDP and refined during second SDP. Both SDPs were focused mainly on producers of plastic and metal parts for automotive and electronic industry and budget for KPMG portion of work, managed by Vladimir Braun, exceeded 0,3 and 0,5 million EURs.

Business Excellence CONSULTING s.r.o., with Vladimir Braun as director, continues to deliver similar services. World Bank has been positively impressed by delivery of SDP in Czech Republic and proposed same type of programme to Serbia and asked Vladimir Braun to train local assessors and perform assessments together with them in two SDPs in period of time from 2006 to 2010. In 2015 there was pilot SDP in North Macedonia and in 2019 restart of SDP in Serbia, where Business Excellence CONSULTING delivered assessment methodology, training of local assessors and performed business reviews alongside with local assessors.
