DESCRIPTION:

Preserved meal, through thermal sterilization, prepared with pork, quinoa, chickpeas and apple sauce.

QUANTITATIVE COMPOSITION:

Water, pork meat 23%, quinoa 20%, chickpeas 13%, carrot 4%, apple, sunflower oil, **wheat** flour, tomato paste, salt, potassium chloride, onion, yeast extract, spices and natural flavouring.

MICROBIOLOGICAL AND PHYSICOCHEMICAL CHARACTERISTICS:

Commercially sterilized. pH 5.8 ± 0.5

SENSORIAL CHARACTERISTICS:

Texture, colour and flavour shall be characteristic of good cooked quinoa, chickpeas and pork. Sauce shall be beige, slightly thick and flavour should be slightly spiced with a apple base.

At the end of shelf life colour will be faded, texture dryer and softer and flavour less intense.

BEST BEFORE DATE:

4 years from the date of production.

The preferable date is printed on the surface with indelible ink.

CONSERVATION CONDITIONS:

Keep in dry and cool area.

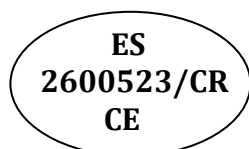
