STATEMENT

This is to confirm that the HI-SCAN 6040 CTiX model S that will be delivered as part of the public procurement procedure ocds-b3wdp1-MD-1761215117713 initiated by your State Enterprise:

- will have ECAC EDSCB standard 3 detections characteristic code 20-71-00.
- 2. will have TSA detection characteristic code 20-52-00 preinstalled/on USB stick (subject to permission from TSA, which should be requested by the end user)
- 3. will be delivered with the following tray model: Smiths Detection tray 3 (PN 34495373). Part number 34495373 noted on the ECAC website represents the SD3 tray with RFID tag. The RFID tag itself has part number 34492301 and does not have an influence on detection.
- 4. will have the EU mark code EDSCB00128 and the labels will be applied on the equipment.
- 5. with the above ECAC certified configuration scanning of liquids up to 2 liters is allowed
- 6. will be integrated with ATRS model iLane A20, which is a product of Smiths Detection, and is fully compatible and can be integrated with the delivered HI-SCAN 6040 CTiX model S.
- 7. will be equipped with software made by Smiths Detection.

Throughout the 2-year duration of the contract, Smiths Detection will ensure, through our Distributor Trident Servicii si Mentenanta SA, at no additional cost:

- 8. updating of the configurations of the EDSCB C3 systems (certified within the CEP-ECAC program) by installing the software versions and/or detection algorithms, which do not involve a hardware upgrade,
- 9. the semi-annual update of the software versions for the EDSCB C3 systems and the security control and centralized management platforms in case new software versions become available. If there is no new software version available, the Airport will be notified in this regard.
