#### 2. OPERATING INSTRUCTION FOR MIA S01

Firstly, lock all the casters after positioning mattress. Make sure that the mattress and the accesso-ries are at room temperature. When you are sure about the cleanliness and the disinfection of the mattress, follow the rules below to locate your mattress as you wish.

Please make an assessment of risk including the following titles before putting the patient into the mattress.

- ✓ Entrapment risk
- ✓ Possibility of falling from the mattress
- ✓ Patients are thoroughly informed on how to use the mattress
- ✓ Curious patients
- ✓ Children
- ✓ Mentally handicapped patients
- ✓ Unauthorized people

#### 3. TRANSFER OF THE MATTRESS

During the transfer of the mattress, pay attention that the mattress and the won't crash anywhere. Otherwise, damage to the mattress or its components may occur.

#### 3.1. Transfer Instructions

1<sup>st</sup> Unlock castors

2<sup>nd</sup> Carefuly transport to desired position

3<sup>rd</sup> Lock castors















#### 4. CLEANING AND GENERAL MAINTENANCE

You must implement the cleaning and maintenance procedures specified in this manual. Otherwise, it may result in injury to the patient or damage to the mattress or its components

Do not expose the mattress to excessive moisture that would allow for liquid pooling. Otherwise, patient injury or equipment damage could occur.

#### **Cleaning Instructions**

1<sup>st</sup> Clean the mattress with a soft, damped cloth and common disinfectants. Do not use too much liquid.

2<sup>nd</sup> Always dry the mattress thoroughly after it has been cleaned.

3<sup>th</sup> Chemical components (ethyl alcohol, thinner, bleacher, anti-limestone etc ...)

Do not use a high-pressure hose in mattress cleaning. Do not use any steam cleaning device on the mattress. Never use water at a temperature of over 60° C. Do not use liquid, especially, through the cleaning of the side rails besides the control panel. Otherwise, it results in failure of applying one or more commands and accordingly an obstacle preventing from using the mattress and these kinds of misuses are not covered by the guarantee.













#### 5. LIMITED WARRANTY AND AFTER-SALE SERVICES

In the event of misusing, damage to the mattress or injury to the patient may occur. Please be careful about the following misusing examples:

- ✓ Use of the mattress for any other purposes except general.
- ✓ Use of the mattress in a high pressure room.
- Use of the mattress by someone not having read the owner's manual or not having been well informed.
- ✓ Using accessories except the ones described by the producer.
- ✓ To use the bend in open air or in a vehicle.
- ✓ Operating and storage in a way which is not defined.
- ✓ Using the mattress in an environment where there is a risk of explosion
- ✓ To use the mattress in an environment where combustible gas or steam exist.
- ✓ To use the mattress in different temperatures than specified.
- ✓ Maintenance of the following items unless performed by authorized people
  - ➤ Actuators
  - > Mechanical Systems
- ✓ Any wrong maintenance,
- Use of the parts or accessories by people who are not authorized by the producer,
- ✓ Violation of the specified maintenance and cleaning procedures,
- ✓ Any different use except the instructions given in the owner's manual (cleaning, service, etc.)
- ✓ A usage violating the conditions defined in the owner's manual.
