The subject of this supplementary certificate is:

- Modification of certified apparatus;

This supplementary certificate describes the change of electric scheme of product, extends facilities and properties of product and adds next supplementary boards. These are the boards:

- Analog inputs board (AI Module 2x current loop 4-20mA);
- Analog outputs board (AO Module 2x current loop 4-20mA);
- Extension board EXT1 with clamps board EXT1-T (2x digital input NAMUR, 6x general digital input, 2x analog input 4-20mA. 2x interface IB1 (RS485) for connection of digital temperature of pressure transmitters;
- Board for connection of external modem (COM0 Module RS232).

The portfolio of used communication modems 2G and LTE is extended.

The power supply of Gas Volume Corrector is extended by possibility of using battery pack B-036D with increased capacity.

There are minor changes in modem part electric scheme.
