The Public Services Agency (PSA) notifies about the results of the evaluation of the bids submitted within the open tendering procurement procedure no. ocds-b3wdp1-MD-1708603966355 of April 11, 2024 for the procurement of the biometric data collection equipment.

Thus, according to the decision of the Working Group for Public Procurement, based on the provisions of art. 69 para. (6) letter b) of Law no. 131/2015 on public procurement, the bid submitted by the economic operator **Speed Identity AB** is not accepted, because it does not meet the requirements set out in the tender documentation, and namely, the economic operator omitted to present the information regarding the fulfillment of the technical requirements set out in the Annex to the Procurement Notice, as follows:

1. For p. 1.1 "Integrated Operator Workstation":

- Equipment and accessories Non-refurbished, produced after 01.01.2023. All requirements are minimum and mandatory; All components must be current and not advertised as EOS (End of Support) / EOL (End of Life);
 - Distance range from 60 cm to 150 cm;
 - Height adjustment Height range: min. 350mm;
- Illumination Dynamic ambient light intensity adjustment, min. 2 independent quadrants (autonomously adjustable by the operator/engineer) for compensation of the differences in light source direction (e.g. window nearby or roof lamps);
- User guidance Colored light ring around the camera with effects(optional);
- Biometric algorithms min. Face detection, quality analysis and capturing algorithms;
 - Aspect ratio 5:3;
 - Resolution min. 800 x 480;

- Display colours min. 16.7 million;
- Luminance min. 420 cd/m2;
- User Guidance Instructions to user on how to properly use the device;
- Status semaphore Light positioned at the top of the unit with 360° visibility (optional);
 - Optical scanning area min. 24 mm x 16 mm;
 - Scan resolution min. 500 DPI;
 - Grey scale 8 bit, 256 grey levels;
 - Display type F-STN;
 - Cover plate surface Tempered glass;
 - Native resolution min. 320 x 200 pixel;
 - Reading technology Electromagnetic Resonance (EMR);
 - Active area size min. 96 mm x 60 mm;
 - Coordinate resolution min. 2540 lpi / 0.01 mm/pt (non-interpolated);
 - Coordinate accuracy ± 0.5 mm (centre);
 - Report rate 200 points per second (non-interpolated);
 - Power supply External 110V-230V, Illuminated power button on panel;
- Dimensions Height: max. 910 mm, Width: max. 320 mm, Depth: max. 600 mm;
- Security Keyed lock with sensor to access the internal components (optional), Keyed lock to access back cabling interfaces and power button (optional);
- Temperature Operation: min. range $10^{\rm o}$ C to $30^{\rm o}$ C, Storage: min. range $0^{\rm o}$ C to $40^{\rm o}$ C;
- Humidity Operation: 20% to 80% RH non-condensed, Storage: 10% to 90% RH non-condensed;
- Hardware requirements for integrated operating software CPU / RAM / Storage in accordance with minimum requirements from the manufacturer in order to assure smooth and agile performance;
 - Integrated operating software functional requirements;
 - Support and maintenance requirements.
- 2. For p. "Illuminated Backdrop, fully compatible with Integrated Operator Workstation":
- Technical specifications of the illumination background for integrated workstation;
 - Warranty period.

Thus, according to the decision of the Working Group for Public Procurement, the contract has been awarded to the winner of this open tendering procurement procedure - the Association "S&T MOLD" SRL (Prime Contractor) and Vision Box - Soluções de Visão por Computador S.A. (Subcontractor) which submitted the bid that corresponds to all the requirements set out in the tender documentation.

Considering the above mentioned, according to the Moldovan legislation, the public procurement contract shall be concluded with "S&T MOLD" SRL (Prime Contractor) and Vision Box - Soluções de Visão por Computador S.A. (Subcontractor).

Accordingly, PSA notifies "S&T MOLD" SRL (Prime Contractor) and Vision Box - Soluções de Visão por Computador S.A. (Subcontractor) about the obligation to present:

- the Performance security (5% of the contract amount), according to the provisions of art. 68 para. (8) of Law no. 131/2015 on public procurement, before the signing of the public procurement contract, a fact provided for in the tender documentation, otherwise, in case of failure to submit the performance security, or in case of the refusal to sign the contract within the period established in the tender documentation, the PSA has the obligation to retain the Bid security.
- the Self-declaration regarding the *Confirmation of the identity of the actual beneficiaries and their non-qualification in the situation of conviction for participation in the activities of a criminal organization or group, for corruption, fraud and/or money laundering*, within 5 days after the date of communication of the results of the public procurement procedure (to the contracting authority and Public Procurement Agency).
