2.1. PRODUCTS DESCRIPTION

Baymed patient gown are made to provide high thermal comfort, high flexibility to the operator. They are made of a hydrophobic soft touché nonwoven material with weight 40 g/m2 SS (2 layer of spunbond nonwoven material) .

2.2. INTENDED USE

This patient gown is designed to protect patients from cross-infection. This patient gown with his soft touché is design to withstand any liquid from one side to the other and ease the movement of the user.

The patient gown of the brand Baymed of Bayteks can be classify in the non-sterile category.

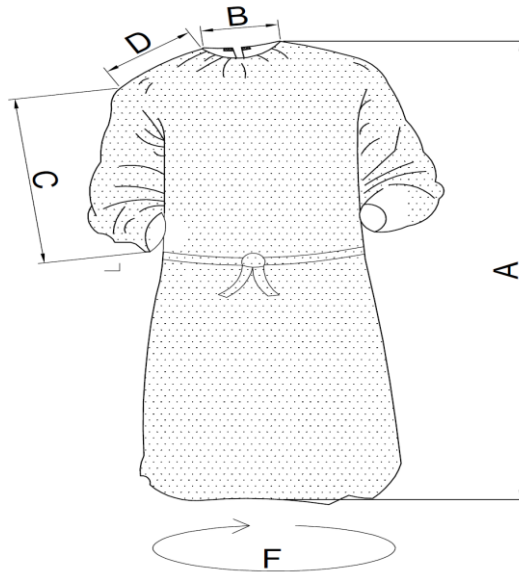
2.4. QUALITY ASSURANCE

2.6. PACKAGING

The patient gown items are packaged either separately; either together in PE transparent bags. A definite number of patient gown in their PE transparent bag are then double packed in order to reduce all the risks they may encounter during their transportation.

The double packed patient gown are put in Baymed standard sized carton which dimensions are Height = 44 cm; Length = 40 cm and Width = 60 cm .
