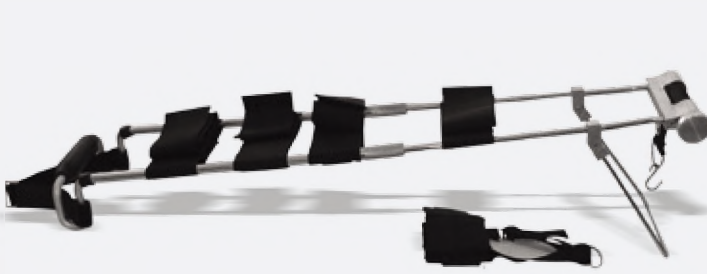


Traksiyon Atel Seti (ET-320)

Traction Splint Set

- Bacak kemiği kırıklarında, bacağı gergiye alarak kırığın birbirine temasını keserek sinir zedelenmesini önlemekle birlikte ağrıyı azaltmaktadır.
- Uzunluğu ayarlanabilmektedir.
- Her iki atelde 4 adet bacak bağlama aparatları bulunmaktadır.
- Metal malzemeden mamul gergi makarası bulunmaktadır.

- In cases of leg fractures, it prevents nerve trauma by cutting touch of the fractures one another by taking the leg into splint and reduces pain.
- Length can be adjusted.
- There are 4 fixing apparatus for leg. It has stretching roller made of metal material.
- Including tensioner pulley made of metal.
