#### **Requirements:**

- NRC reserves the right to accept or reject the whole or part of your proposal based on the information provided. Incomplete proposals which do not comply with our conditions will not be considered.

- <u>Step 1</u>: Administrative compliance check: Each proposal will be checked to ensure compliance with all the EOI requirements.
- <u>Step 2</u>: Technical Evaluation: All bids will be technically evaluated based on the results from Annex No 1 Mapping out the shelter (Houses) Repairing Service Providers

#### Payment terms:

• NRC offers standard payment within 30 days of receipt of goods/services, by bank transfer only.

NRC is obliged to ensure that its procurement decisions are clearly justified and documented and keeping within the Donors mandatory principles. In that regard, full and onthe-spot access must be granted to representatives of NRC, the Donor or any organisation or person mandated by it, to premises belonging to NRC or its contractors. The right to access shall include all documents and information necessary to assess, or audit the implementation of the contract.

NRC also expects suppliers who process personal data to comply with the General Data Protection Regulation (EU GDPR) and any relevant national legislation. Suppliers processing personal data on an NRC contract will be required to sign a data processing / sharing agreement as part of the contract.
