STANDARD FORM OF THE SINGLE DOCUMENT SINGLE EUROPEAN PURCHASING DOCUMENT

1. The Single European Procurement Document, (hereafter, SEPD) is a declaration on own responsibility, by which the economic operator confirms the fulfillment of the qualification and selection criteria required in public procurement procedures in the Republic of Moldova.
2. The form is filled in, signed electronically and submitted to the contracting authority upon submission of the tender.
3. A SAAD submitted by the economic operator in a previous public procurement procedure may be re-used, provided that the information contained in the form is correct and valid at the date of its submission.
4. A tenderer who submits false information in the SAAD or the supporting documents submitted do not confirm the information indicated in the document submitted shall be excluded from the public procurement procedure and/or may be liable in accordance with the law.
5. The DUAЕ form consists of 7 chapters, namely:
 - 1) Chapter I. Information on the public procurement procedure and the contracting authority/entity;
 - 2) Chapter II. Information relating to the economic operator;
 - 3) Chapter III. Grounds for exclusion from the public procurement procedure;
 - 4) Chapter IV. Criteria for qualification and selection of economic operators;
 - 5) Chapter V. General indications for the selection criteria for economic operators;
 - 6) Chapter VI. Pre-selection of candidates for the public procurement procedure;
 - 7) Chapter VII. Final declarations.
6. Submission of the DUAЕ form when submitting the tender that does not comply with the requirements set out in the Tender Documentation leads to rejection of the tender.
