#### VIII. Use

First, disinfect the surface with a Surfaces Biocide (Disinfectant), let dry and then apply two layers of paint.

Apply the Biocidal Product by brush, roller or airless spraying.

Consumption: 1 L of Biocidal Product for 6-7 m<sup>2</sup>.
