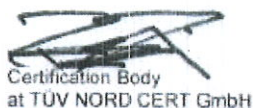

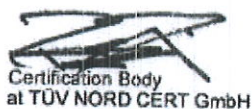

1. Warranty Period & Service

Products shipped by Planet Technology Corp. are covered by a return-to-base warranty period of **2 years (24 months)**, excluding the following categories.
