Manufacturer's Authorization

WHEREAS:

EMS Mobil Sistemler AS, is a reputable manufacturer of EMERGENCY AMBULANCES, having our factories at Ahi Evran OSB Mah, Kirim Hanligi Cad, No: 9, 06930 Sincan, Ankara, Turkiye,

We hereby authorize the company SRL, "MERCURIY TRADE", (IDNO 1012600033071, registry date: 24.10.2012) registered with the address MD-2004, street. Toma Ciorbă 24/2, mun. Chișinău, Republic of Moldova, to submit a Bid, and eventually negotiate and sign a contract with the contracting authority for the following supplies manufactured by us, WITH THEIR OWN NAME AND ACCOUNT*:

3 units EMS Emergency Ambulances on Ford Transit Van. Delivery and hand over of the ambulances to the Contracting Authority in Republic of Moldova will be under the full responsibility of "MERCURIY TRADE" SRL.

* By providing this authorization, EMS will be responsible only against the company "Mercuriy Trade" SRL to provide required ambulances in the tender, in accordance with the compliance document and proforma invoice we provided for them. Mercuriy Trade SRL will be fully responsible only against the contracting authority, for the final delivery of the ambulances.

Warranty Clause:

We will extend our warranty for THREE YEARS or 200.000 km, whichever comes first, for the ambulance conversion and equipment we provided on the base chassis. Warranty period for the medical devices will be ONE YEAR against manufacturer's production faults.

Base chassis vehicles will be under warranty of FORD with standard terms and conditions applicable in Moldova. The Ford warranty will be available from any authorized Ford Dealer in the Republic of Moldova. Pre-delivery inspection MUST be completed by a local authorized Dealer before the first use. The cost for this service will be paid by the buyer.

We declare that the supplies used for ambulance conversion will be new, unused, of the most recent models and incorporate all recent improvements in design and materials, unless otherwise provided in the contract. We further declare that all supplies will have no defect arising from design, materials, or workmanship, except insofar as the design or materials are required by the specifications.

We will be responsible for making good any defect in, or damage to, any part of the supplies used for ambulance conversion which may appear or occur during the warranty period, and which results from the use of defective materials, faulty workmanship, or design of the manufacturer. Any defects arising from user or operation faults, or natural tear down will not be covered. Manufacturers' warranty terms and conditions may apply for the devices and equipment, which are supplied in the ambulances.
