

# AbsoClear® Family



## Description:

**AbsoClear®, AbsoClear® Comfort** and **AbsoClear® OTC Bandages** (sterile and non-sterile) are Super Absorbent Hydrogel wound dressings that have the ability to absorb water. Super Absorbent Dressing is a new generation of advanced wound dressing, the construction made it ideal for heavily exuding wounds; the dressing absorbs wound exudate through the wound contact layer, retains the exudate within the core and minimizes the risk for maceration.

**AbsoClear®** is water clear hydrogel sheet dressing, made of ionic polymer and glycerol, laminated with waterproof, bacteria-proof and virus-proof film.

**AbsoClear® Comfort** is same composition of **AbsoClear®** but the polyurethane adhesive film extends to act as adhesive border, with **AbsoClear®** island pad at central position.

**AbsoClear® OTC bandages** (sterile and non-sterile) are same as **AbsoClear® Comfort** but it is used for retail market. They have smaller size than **AbsoClear® Comfort** wound dressings.

## Features:

1. **Superabsorbent Gel:** **AbsoClear®** can absorb wound exudates up to 14 times its original weight as same as alginate and foam wound dressings. This results in longer wear time and reduction of risk of maceration.
2. **Sticky Gel:** Unlike water-based hydrogels, **AbsoClear®** adheres once applied, so it might not need fixation tape or secondary fixation dressing and allows easy application.
3. **Wound environment:**
  - a) **AbsoClear®** creates moist wound environment upon absorption which is important in promoting the wound healing. It also allows easy removal without pain or trauma during the dressing change.
  - b) **AbsoClear®** provides cooling effect and instant relief of burn sensation.
4. **Clear:** **AbsoClear®** allows easy monitoring of the wound healing process without removal of the dressing. Accordingly, it is more cost effective than opaque dressings.
5. **Debridement:** **AbsoClear®** creates moist wound environment which helps breakdown of necrotic tissues and slough, where they are lifted off the wound due to the osmotic nature of the gel.  
In addition, this osmotic nature helps to draw fluid from underlying tissue to the wound bed.

## Intended Purpose :

**AbsoClear®** and **AbsoClear® Comfort** are used for pressure ulcers, diabetic foot ulcers, skin tears, abrasions, donor sites, superficial burns and clean closed approximated surgical wounds and laparoscopic incisions. It can also be used as a secondary (cover) dressing over wound fillers (such as alginate dressings).

**AbsoClear® OTC bandages** (sterile and non-sterile) are used for blisters, corns, calluses and bunions.
